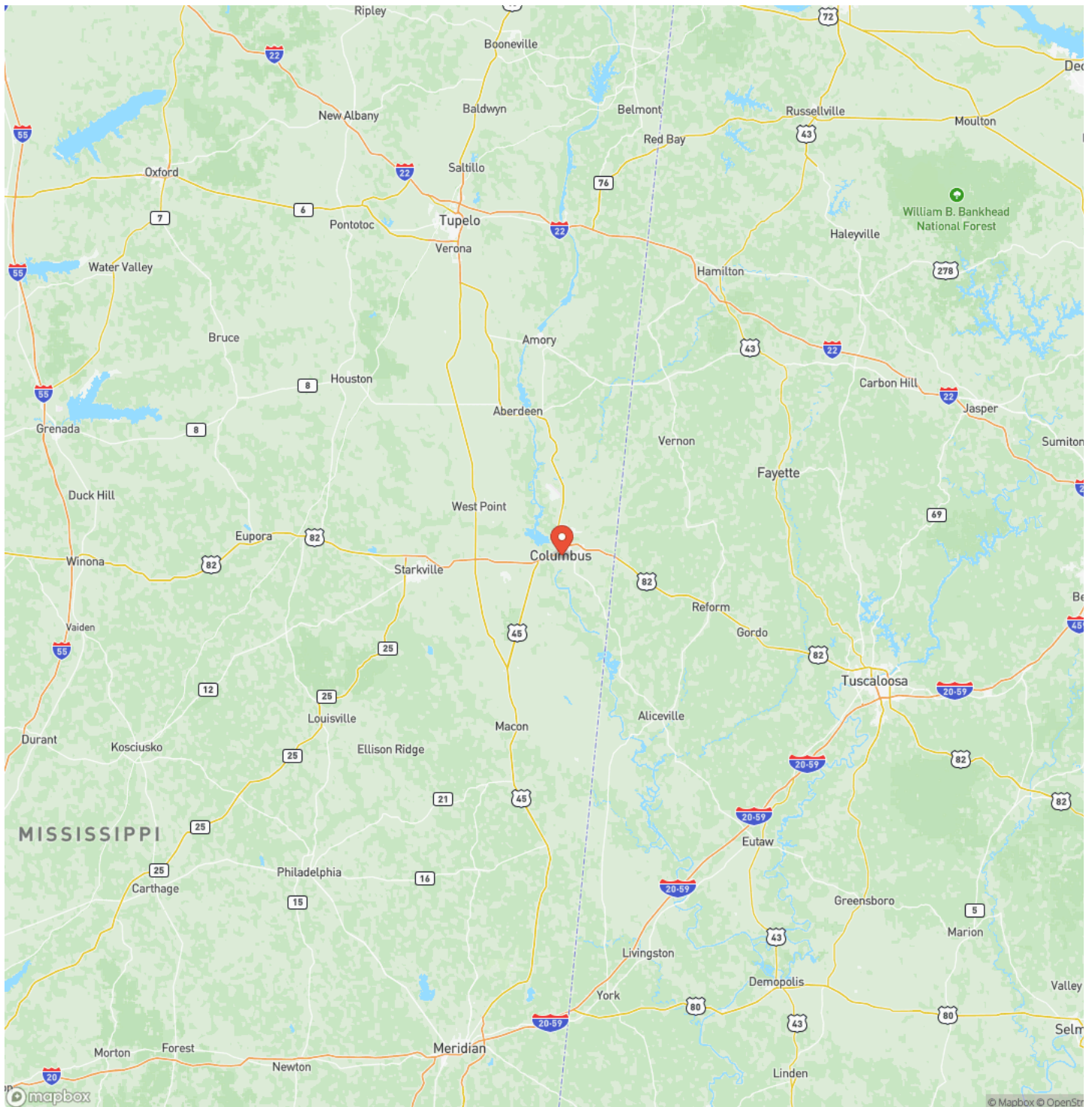




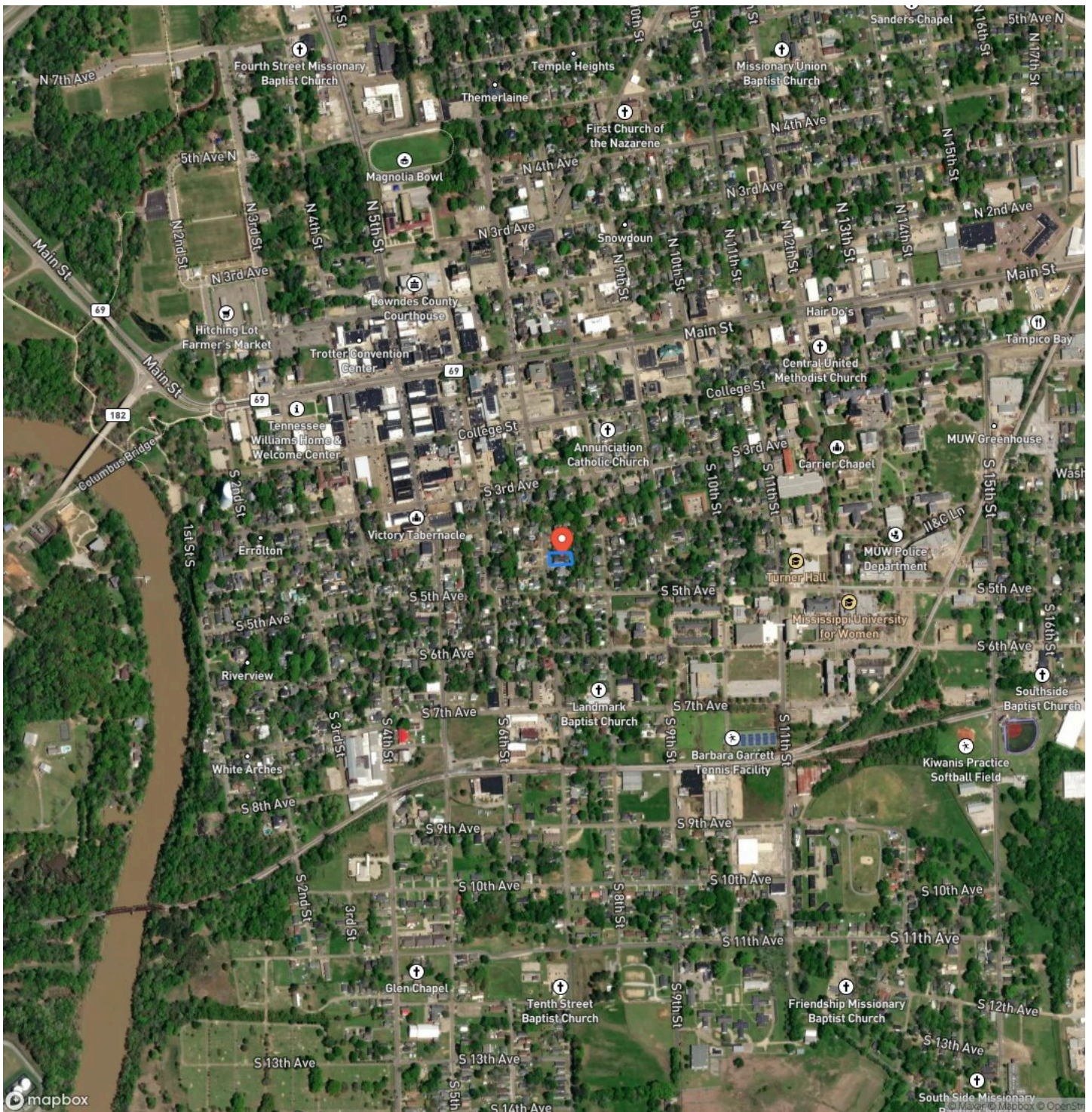
Locator Map

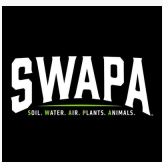
