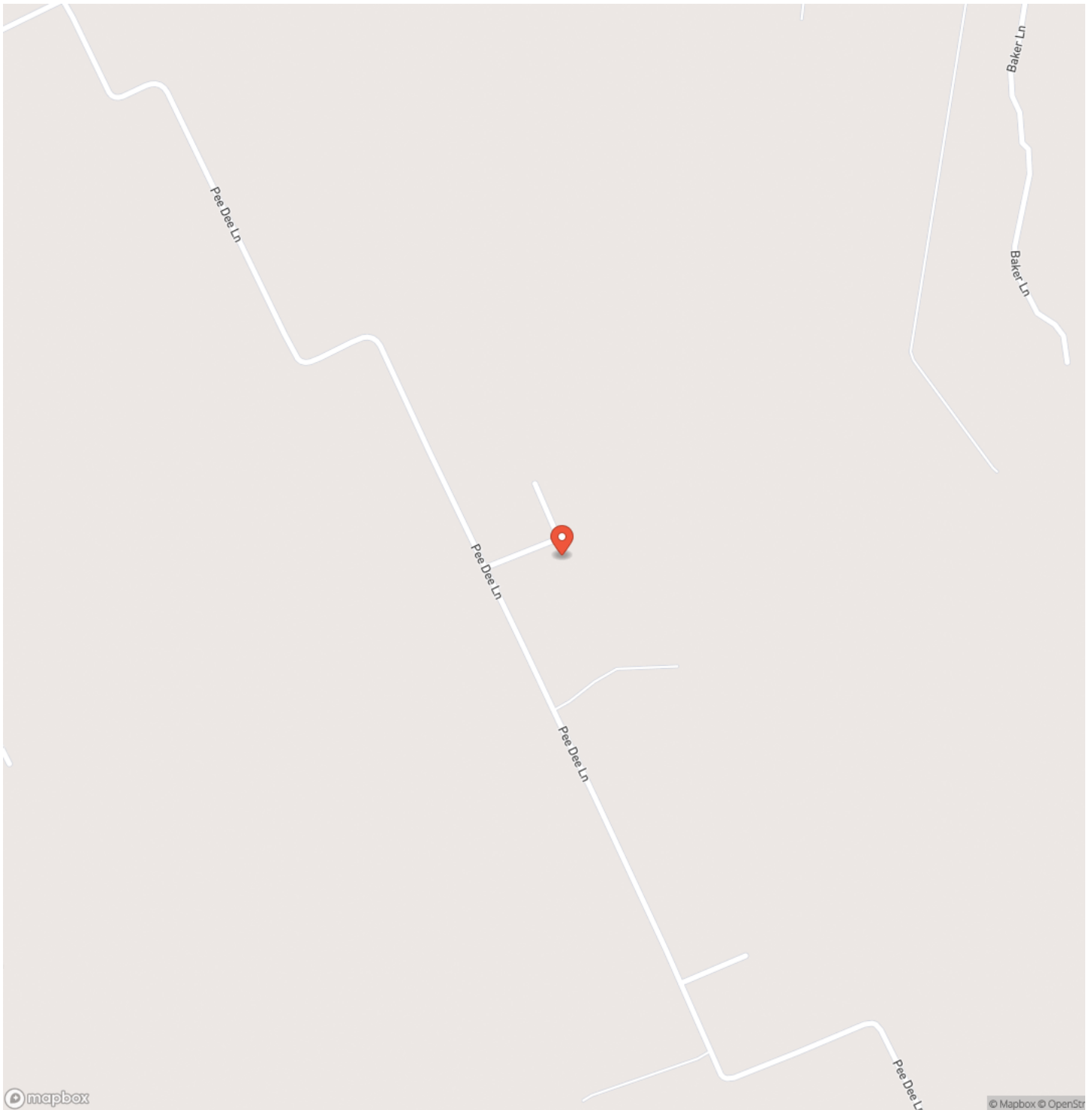

Mobile home will be removed from property. 15.5 acre parcel to the north is for sale as well totaling 31 acres. New survey is required.

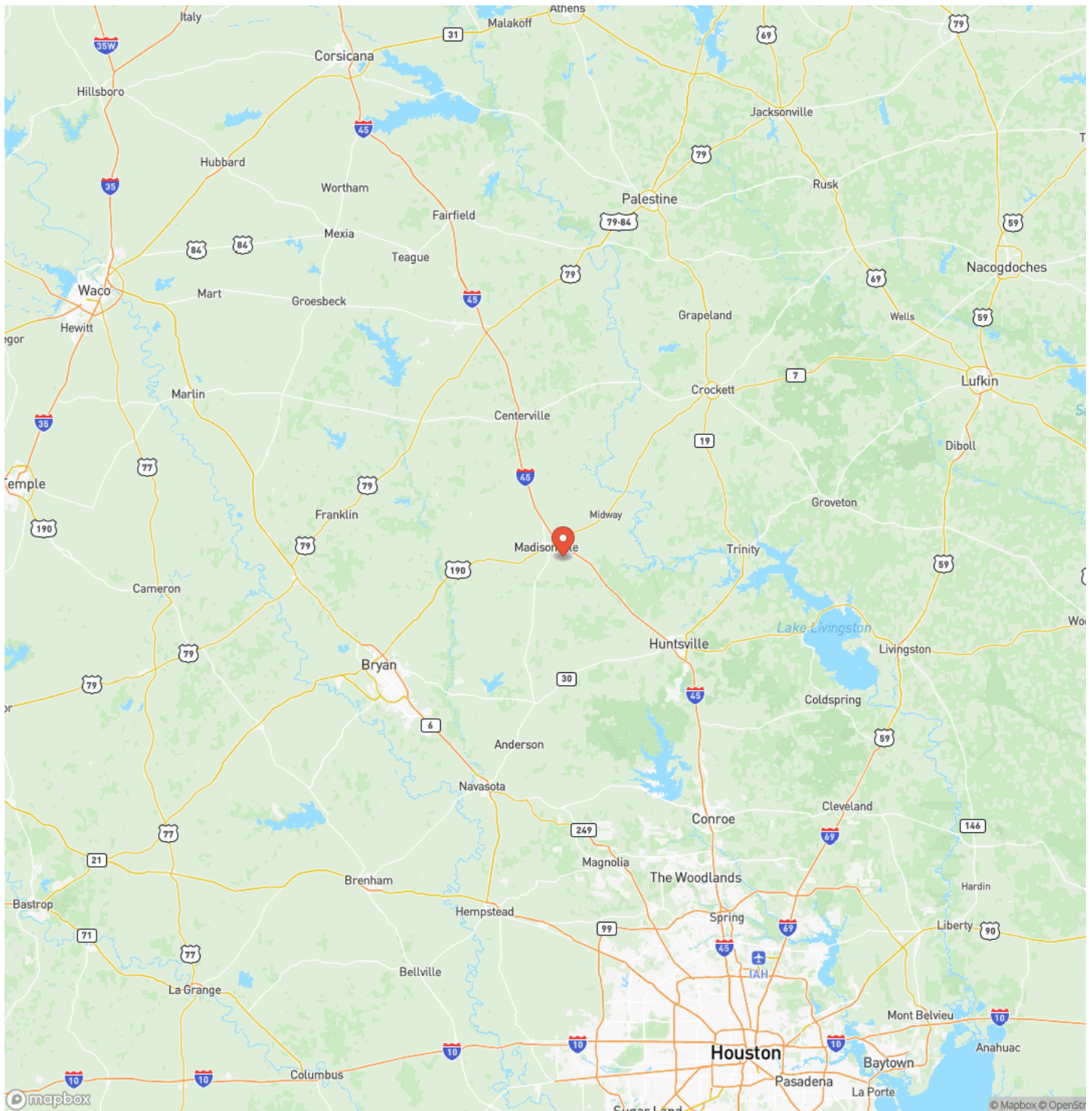
