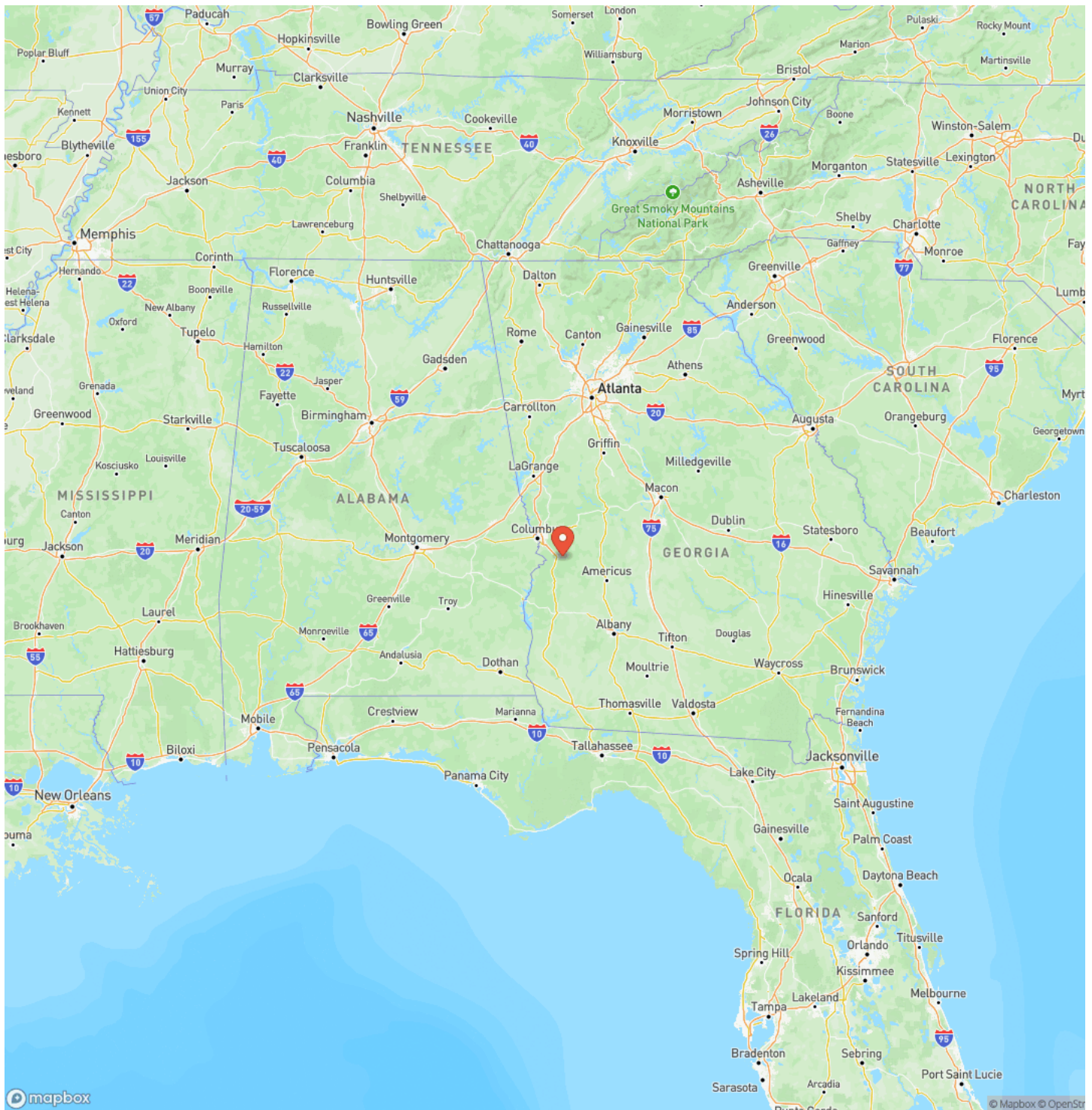

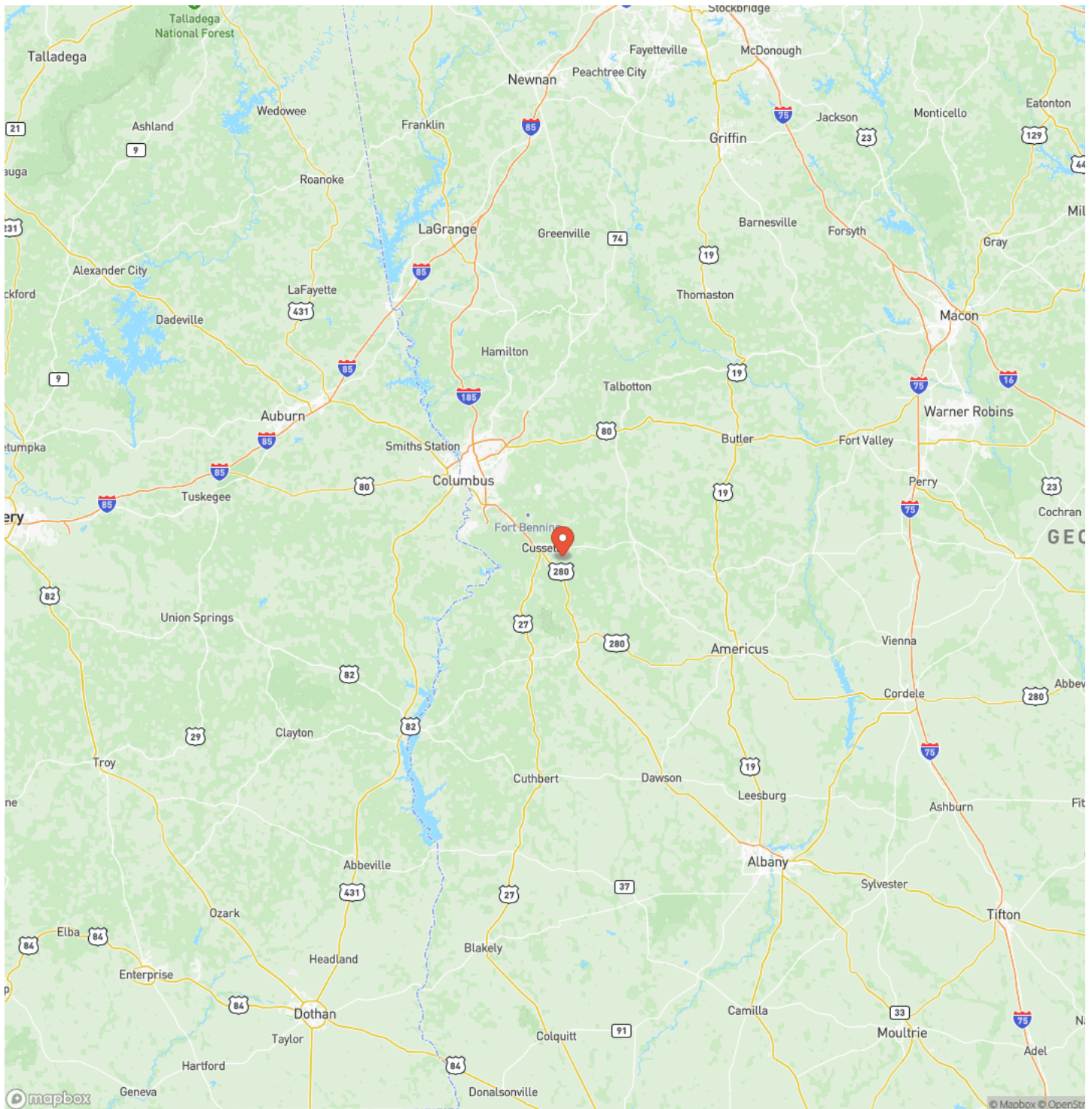
Locator Map
