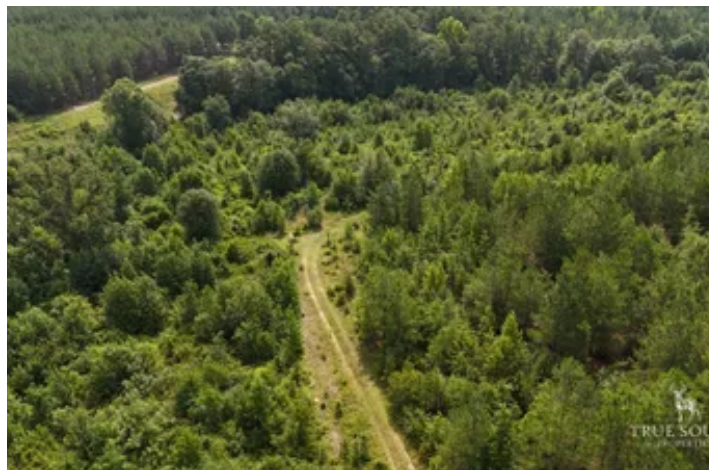

PROPERTY DESCRIPTION

The Rose Tract is a rare 119.84-acre farm and recreational property offering versatility, character, and endless potential in Allendale County. This unique tract features two separate residences, one approximately 1,500 square feet and the other approximately 1,360 square feet, making it ideal for a family compound, guest accommodations, rental income, or multi-generational use.

Both homes are classic older farmhouses full of charm, with beautiful heart pine found throughout. The main house is set beneath a canopy of mature live oaks and pecan trees, creating a timeless Lowcountry setting, and features a fenced yard along with notable barns that enhance both function and appeal.

Improvements on the property include multiple outbuildings suited for storage or a variety of uses, as well as an impressive 40x60 metal shop with three bay doors situated on an 8-inch fibered concrete slab.

The land itself is a strong blend of usability and natural beauty, with mixed timber consisting of loblolly pine and hardwoods. Several excellent pond sites are scattered throughout the tract, and the wildlife presence is exceptional, offering opportunities for deer, turkey, duck, and dove hunting.

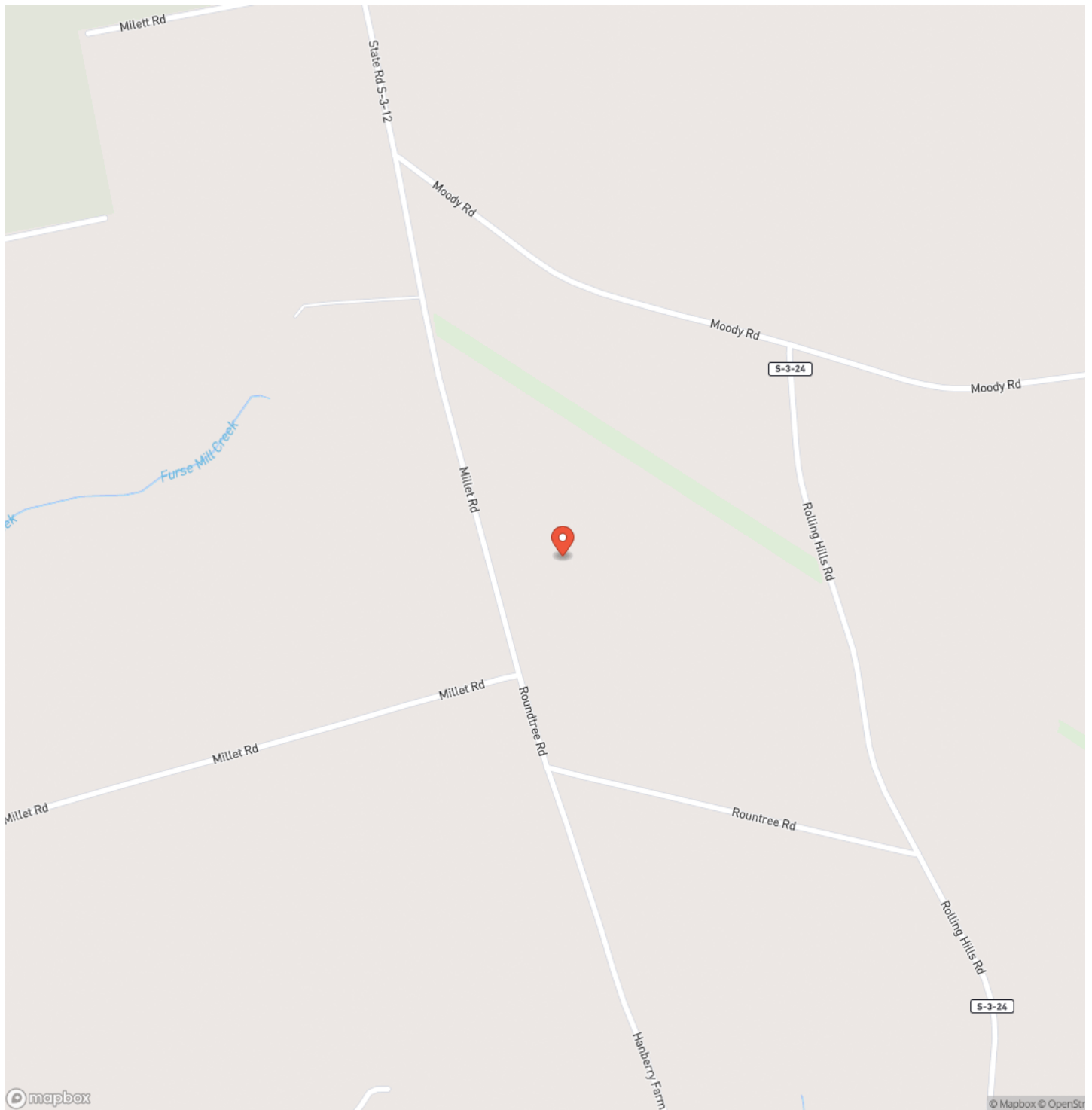

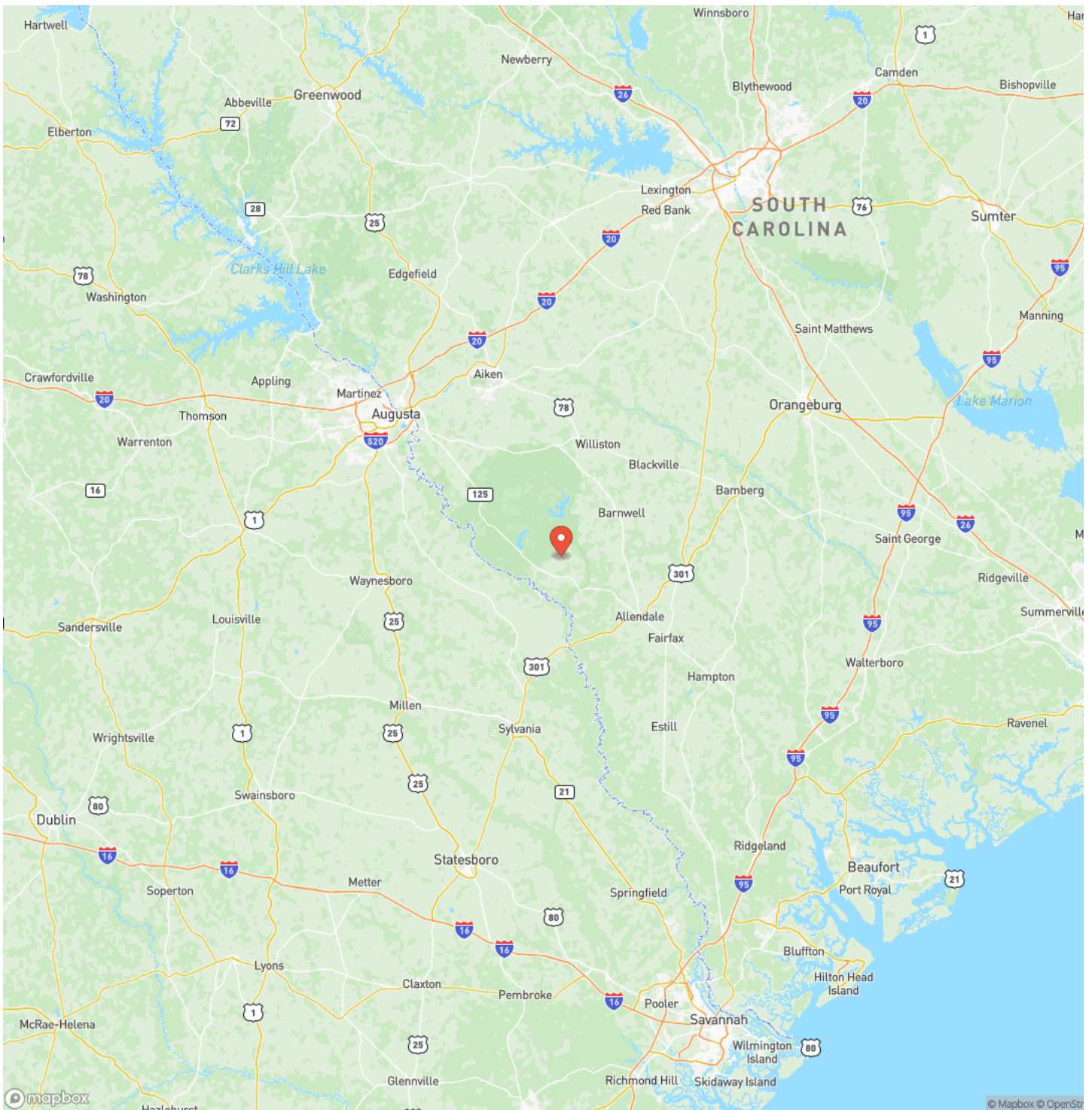
