The centerpiece of this ranch is a beautifully updated 5,420 sq. ft. home, featuring 5 spacious bedrooms and 4.5 baths. In addition to the main house, there's a separate 1 bedroom, 1 bath in-law/housekeeper house, ensuring comfortable accommodation for guests or staff. The property also includes two wells and two septic systems to easily handle the water and waste. You'll also appreciate the fenced backyard, perfect for keeping dogs safe and secure, as well as a gardening shed, greenhouse, and planting boxes for cultivating your green thumb.

With about 45 acres of timber and 209 acres of irrigated ground, this property has been thoughtfully developed for wildlife, hunting, and fishing. You'll find an abundance of Mule Deer, Waterfowl, Valley Quail, and Pheasant. The two 6-tower Valley pivots ensure the most efficient irrigation possible. For those interested in cattle ranching, the property can support around 75 cow/calf pairs, and the well-equipped corral system features several pens with a Powder River squeeze chute and semi-truck loading chute.

Numerous ponds, food plots, and a year-round spring (Brown's Spring) enhance the property's appeal, with Brown's Spring flowing for nearly a mile before joining the Sycan River on your deeded acreage. A new multi-ton private bridge has been installed in the middle of the property, providing a clean and convenient crossing of the Sycan River.

With the recent removal of dams in the Klamath area, the river is now open to the Pacific Ocean, adding to the property's unique appeal. The ranch is conveniently located just 42 miles from Klamath Falls and only 2 hours from Medford, Oregon, making it easily accessible.




Locator Map
