The 15 acres of old ag land has been transitioned into a mixture of CRP grass and 8 to 9 acres of food plots. On the northernly boundary line, you will find a strategically placed 2.5 acre staging plot planted in Buck Forage Oats. The food plot is surrounded by CRP and is at the top of the ridge line.

On the southern end of the property, you will find an 8-to-9-acre field surrounded by CRP grass with 5.5 acres which was planted in soybeans and corn. Both food plots are strategically located at the top of the ridge system which allows for you to strategically place stands along the transition lines, draws, and valleys to intercept the local deer herd as they come for the afternoon meal prior to heading out to the destination ag fields in the evening.

Stands have been strategically placed throughout the property in various locations to maximize the full use of the property during all phases of the hunting season.

As you can tell by the trail cam photos there are phenomenal genetics in the area and the local landowners strive to let these big boys hit higher age classes.






Locator Map






Locator Map
