BEING A TRACT OR PARCEL OF LAND SITUATED IN YOUNG COUNTY, TEXAS, AND BEING OUT OF THE SAN ANTONIO AND MEXICAN GULF RAILROAD SURVEY NO. 262, THE THOMAS J. JORDAN SURVEY, ABSTRACT NO. 1466, THE M. A. FULLER SURVEY, ABSTRACT NO. 1426, THE CLAIBOURN HUGHES SURVEY, ABSTRACT NO. 139, AND THE S. G.
