


This property is 181.28 ac +/- is a productive multi-age timber investment spanning the gap from freshly planted trees to merchantable and ready for harvest. Located near Bonifay, FL with road frontage on two different paved roads makes this a great investment to capture timber growth and capitalize on the economic growth of the surrounding area.

About 46 acres of the property is in young planted pine that is healthy and growing fast. 25 acres were just planted in new pine plantation this year, and approximately 20 acres is in mature pine that can be harvested any time. The remainder of the property is in natural pine and hardwood forest providing excellent wildlife habitat and natural beauty.

The property is just a few minutes from Bonifay, FL and has paved road frontage along both Boswell Rd. and Bonifay Gritney Rd., creating a variety of options for homesites or potential development. The property also has limited rail frontage, and very close proximity to Hwy 90 - a major north FL thoroughfare. Power is available on the boundary.





Locator Map




