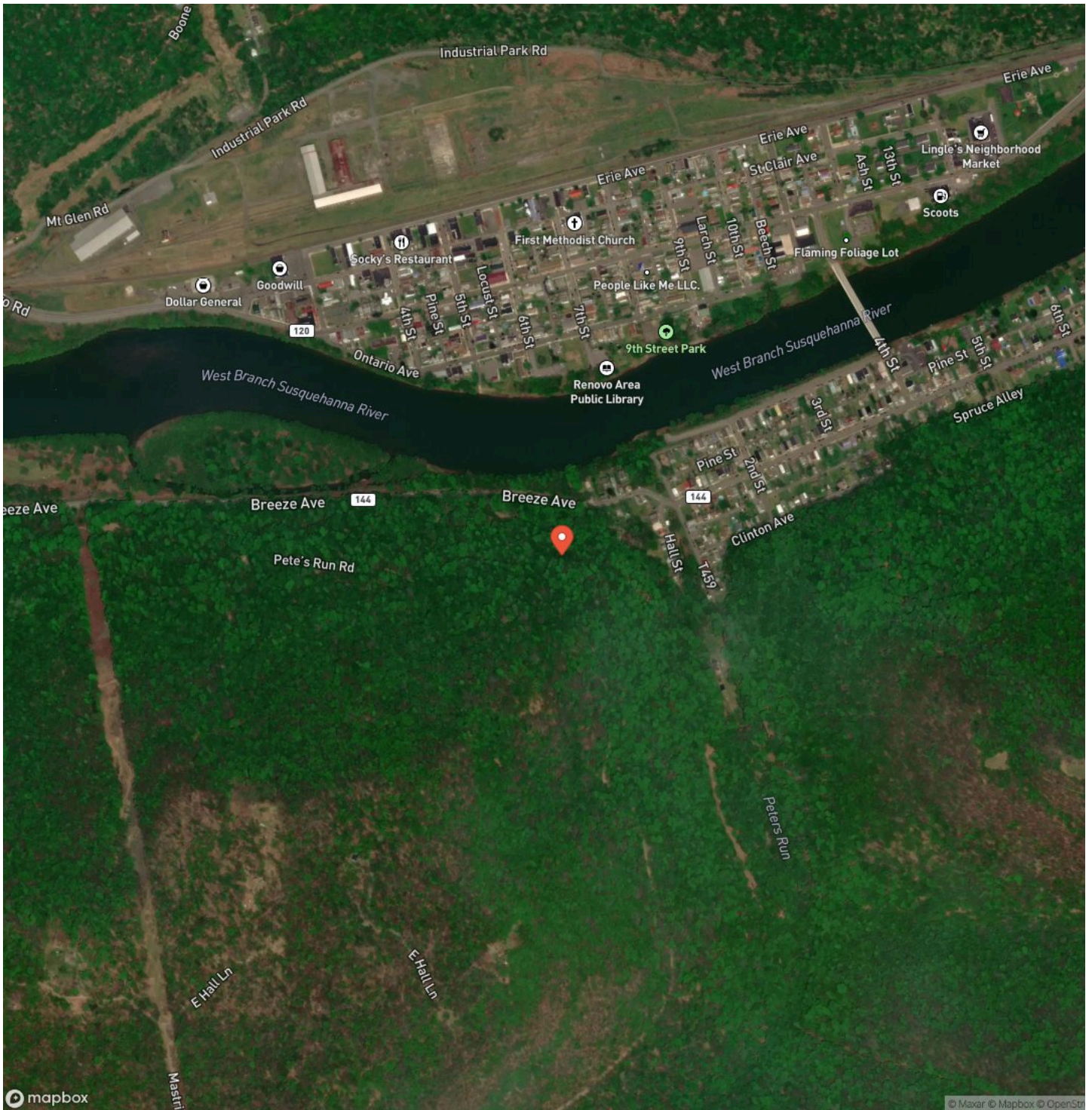
# Locator Map
