For Sale! 107.18+/-acre property in Crenshaw County, Alabama, offering a rare combination of outstanding deer and turkey hunting and professionally managed mature timber. The current owners have maintained a strict wildlife management plan on this tract and it shows in not only the amount, but the quality of game on the property. There are several well established food plots that have been planted with soybeans for summer forage. The timber consists of mostly mature loblolly stands that have been burned regularly and provide excellent turkey habitat. Complementing the loblolly stands are stream zones and bottoms that consist of mature hardwoods. Approximately 12 acres along the road frontage is planted in longleaf pines which provides an aesthetically pleasing entrance to the property. A well developed road system provides access to all parts of the tract and also simplifies fire break maintenance. The owners have consistently taken trophy bucks from the property in years past and the turkey population is abundant.

Conveniently located just 16 miles east of I-65 (Greenville exit)




