The 2-bedroom one bathroom cabin is 1000 sq. feet, and the sellers are willing to work with buyers about leaving it fully furnished. The cabin and 2 car garage were built in 2021 and offers everything including city water, electricity, and a mini split heating and cooling system keeps the cabin at comfortable temperatures year- round. The small wood fireplace helps heat the cabin on cold winter nights.

Don't forget about the excellent deer and turkey hunting as well as consistently good morel mushroom hunting on this property. There are existing trails to navigate on a UTV for easy access to and from stands. Some covered box blinds and stands will stay with the property. The 10.5 acres of tillable ground help provide food and approximately \$1,400 in annual income. 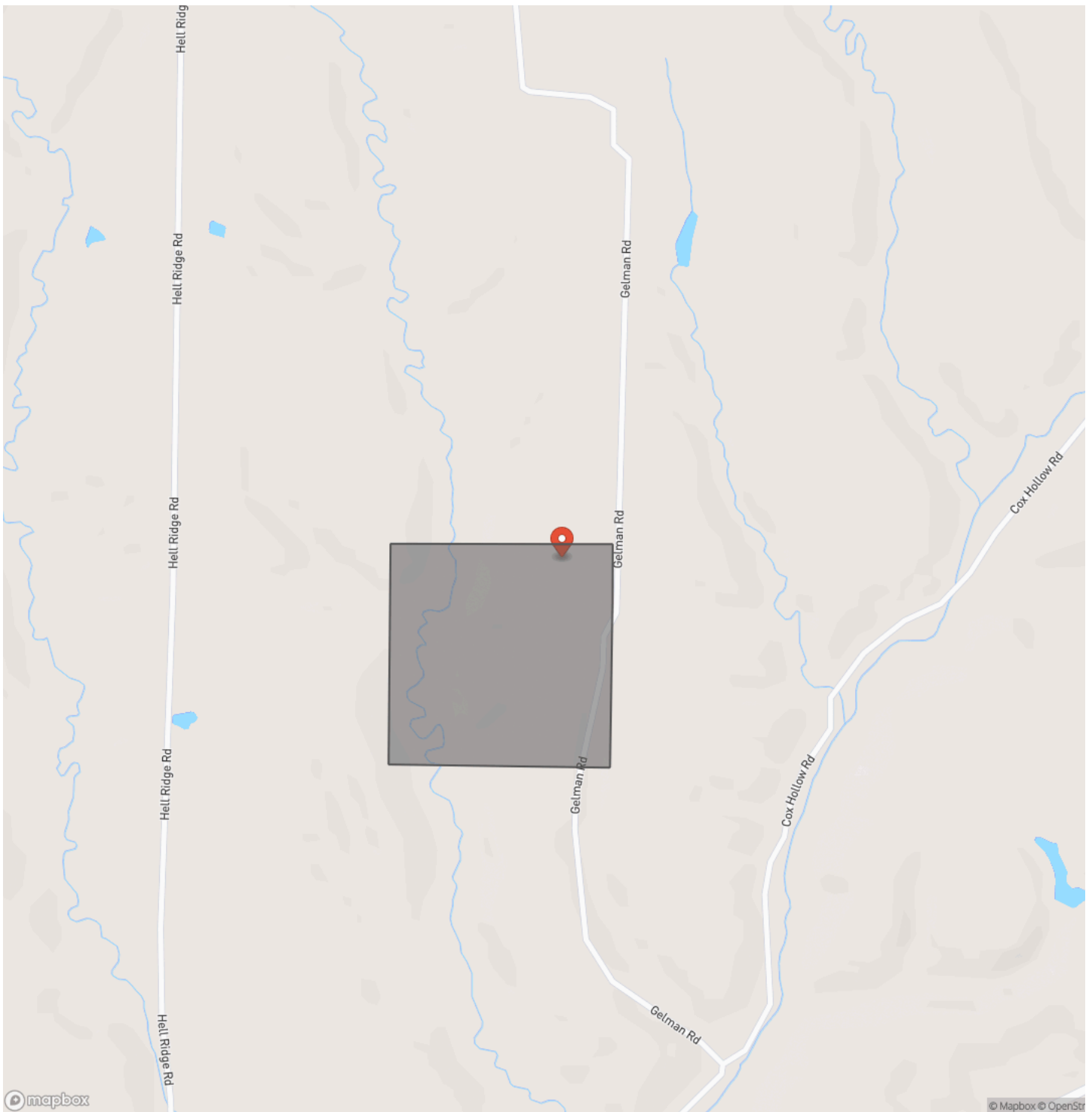

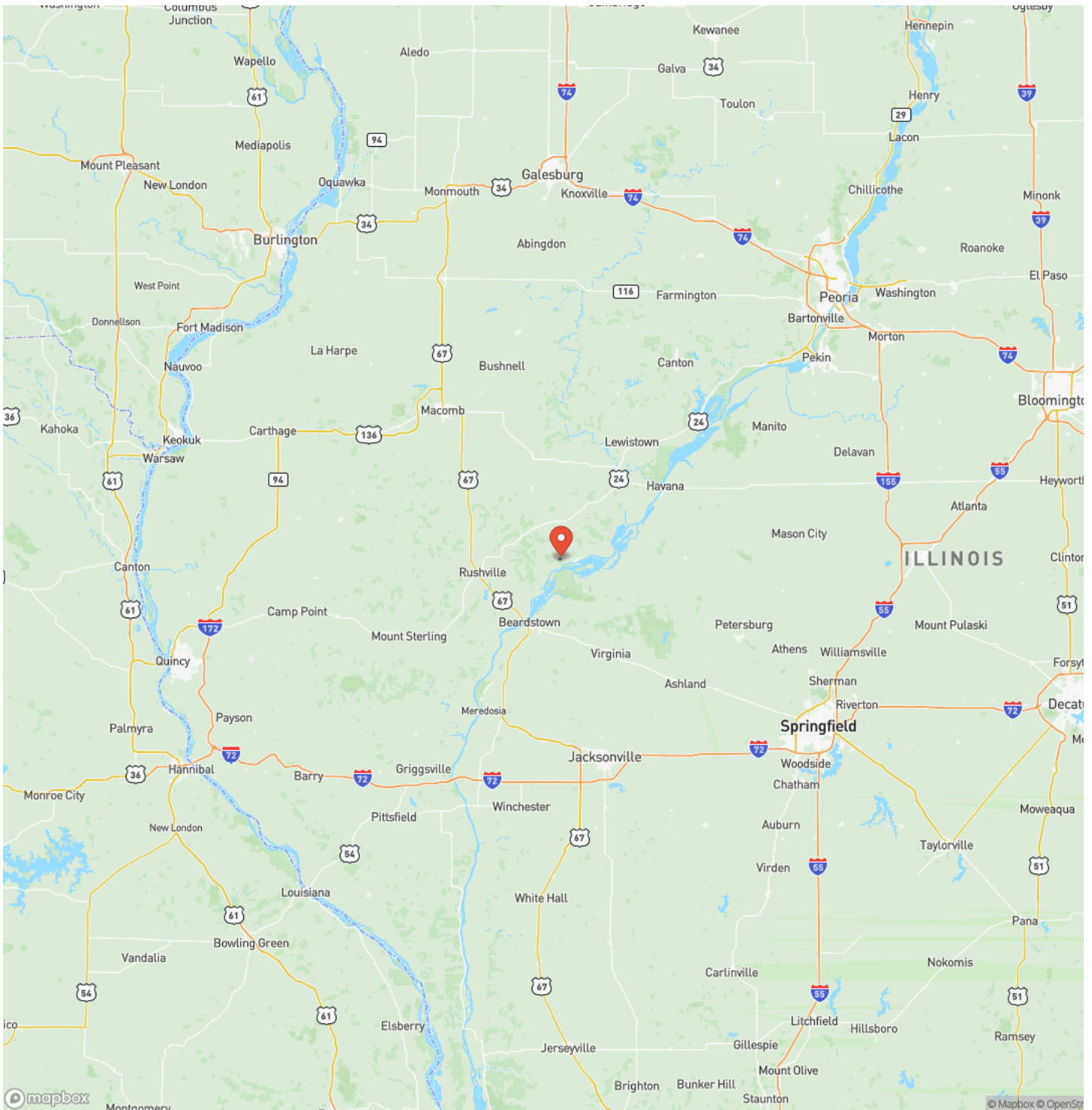
