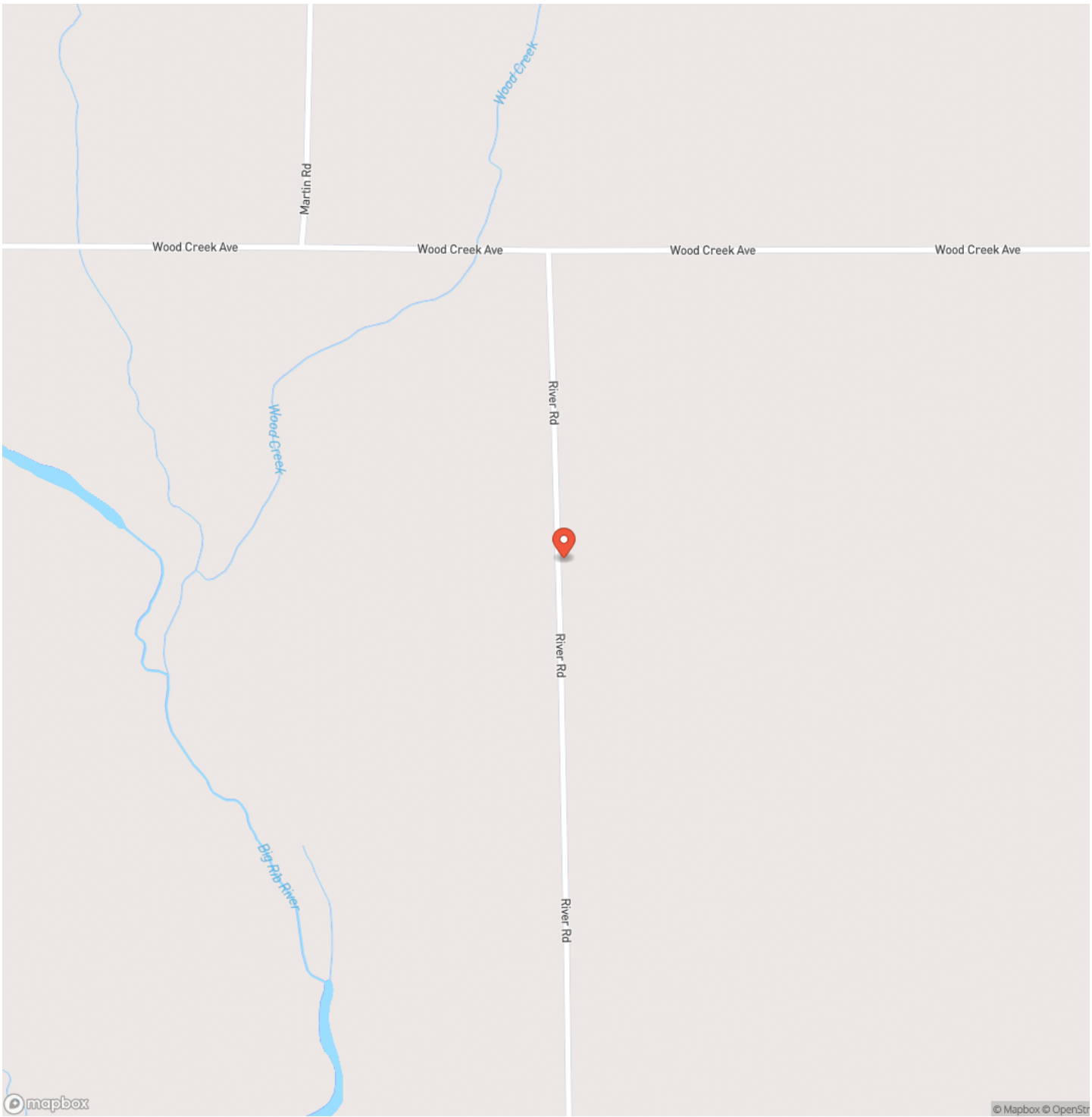

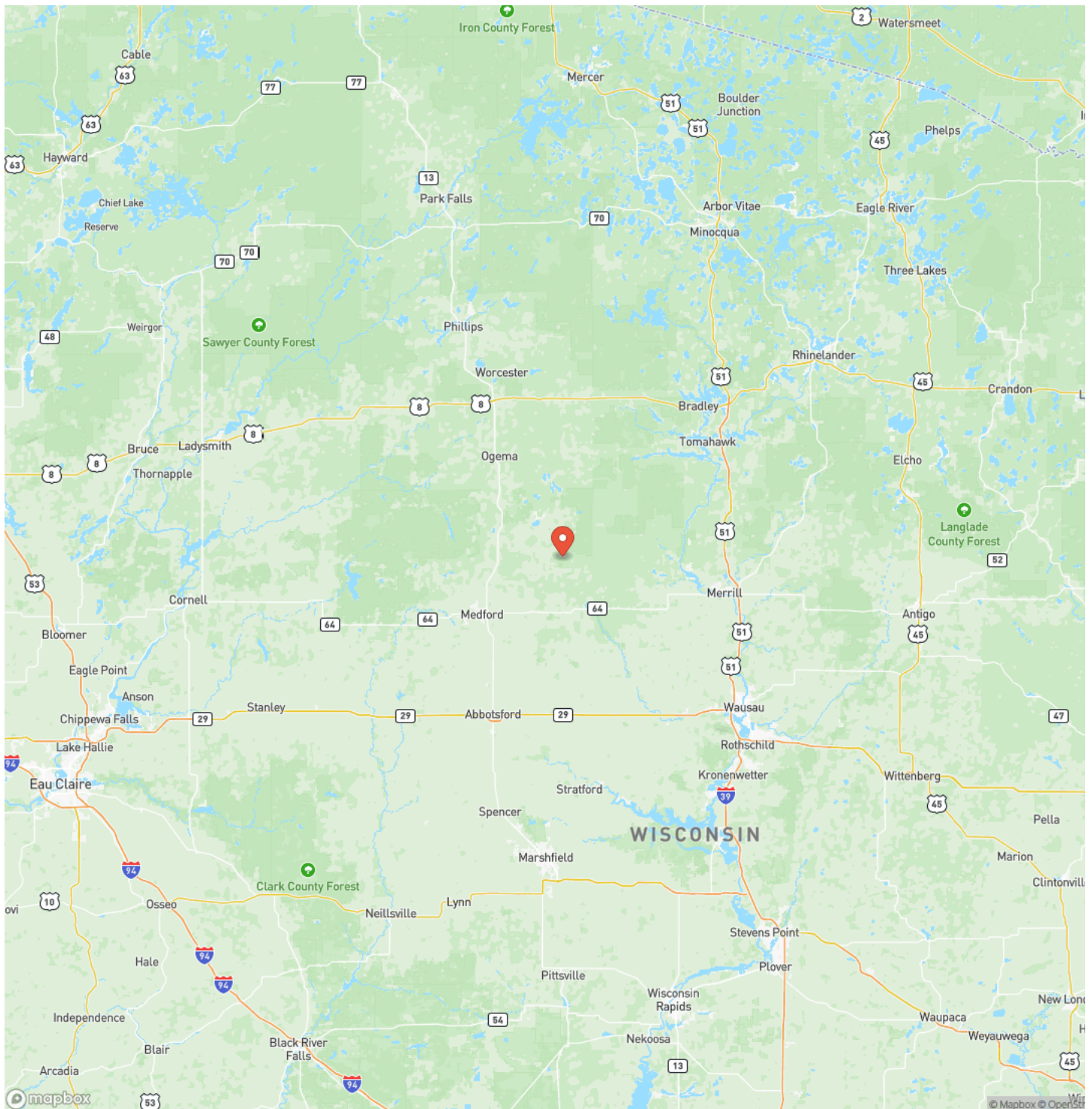

Locator Map



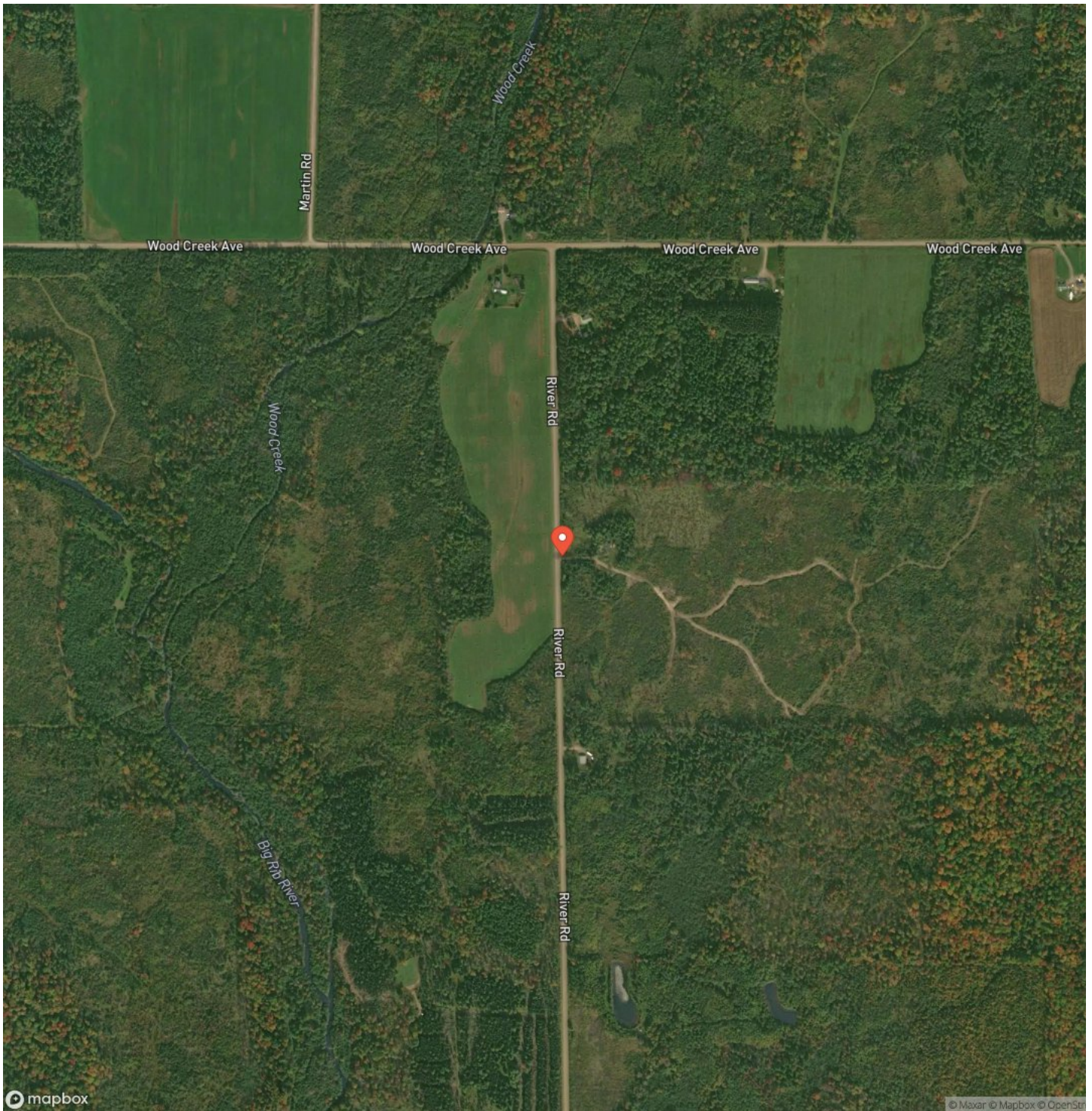
