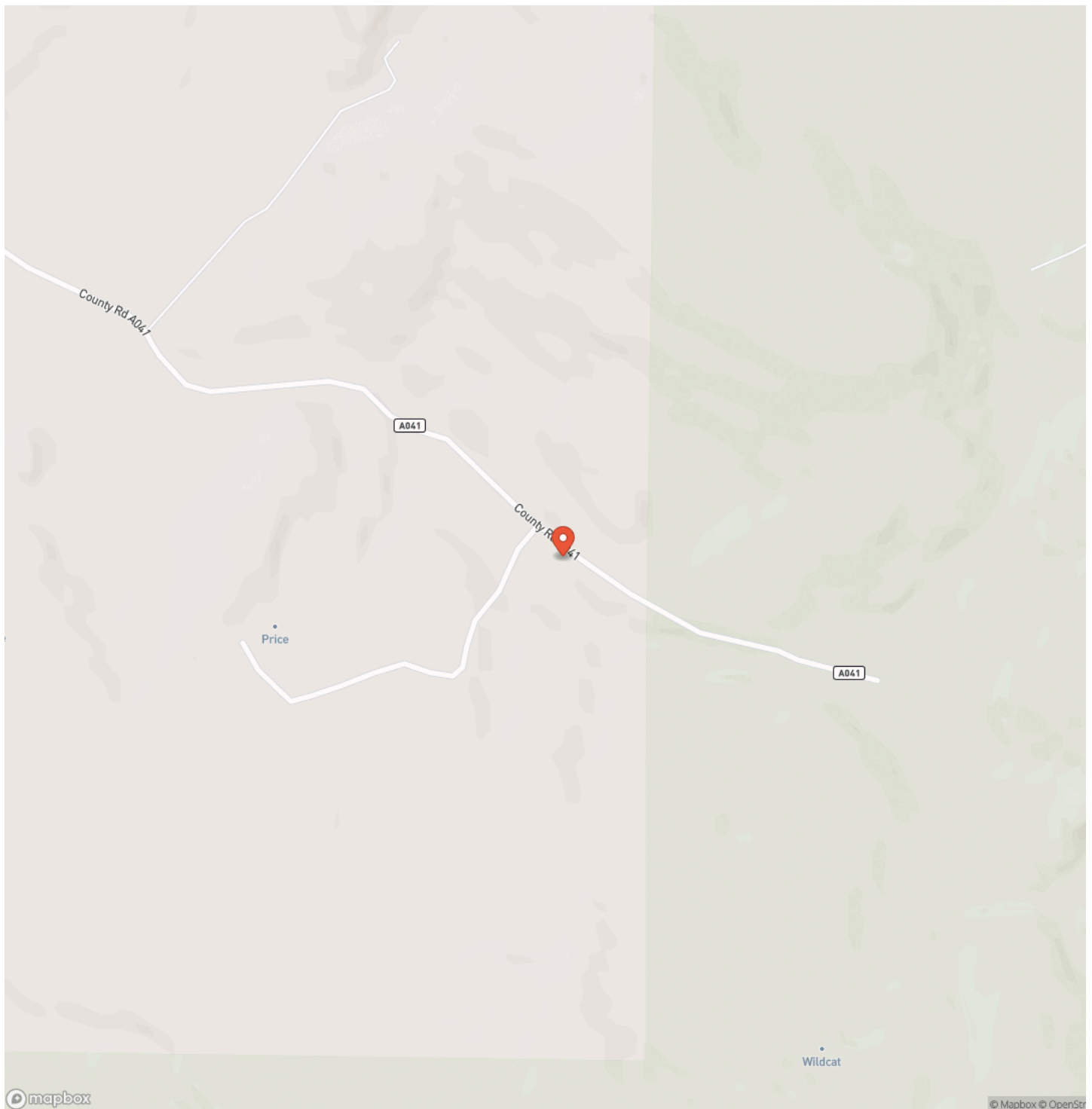

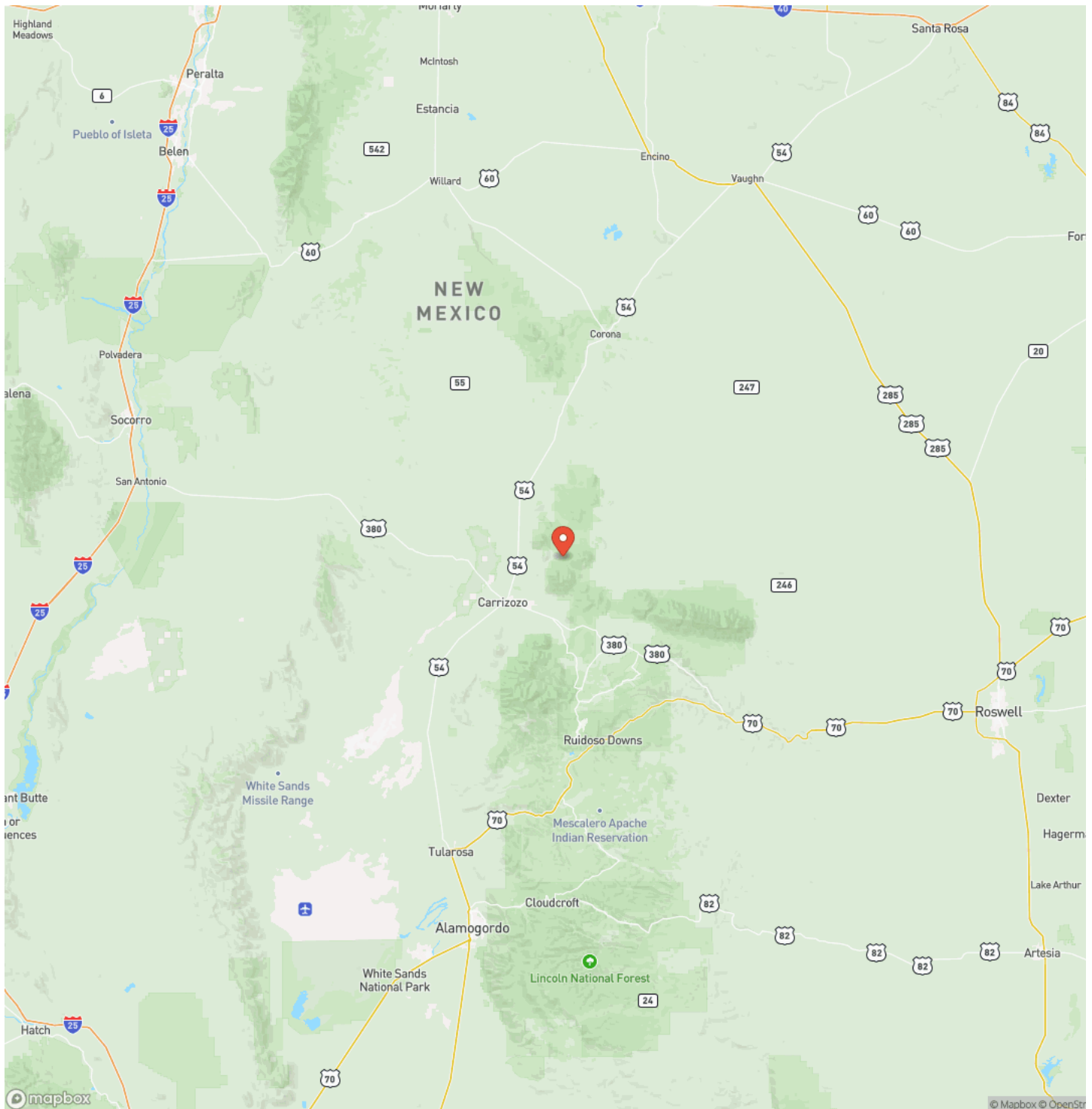

## Locator Map

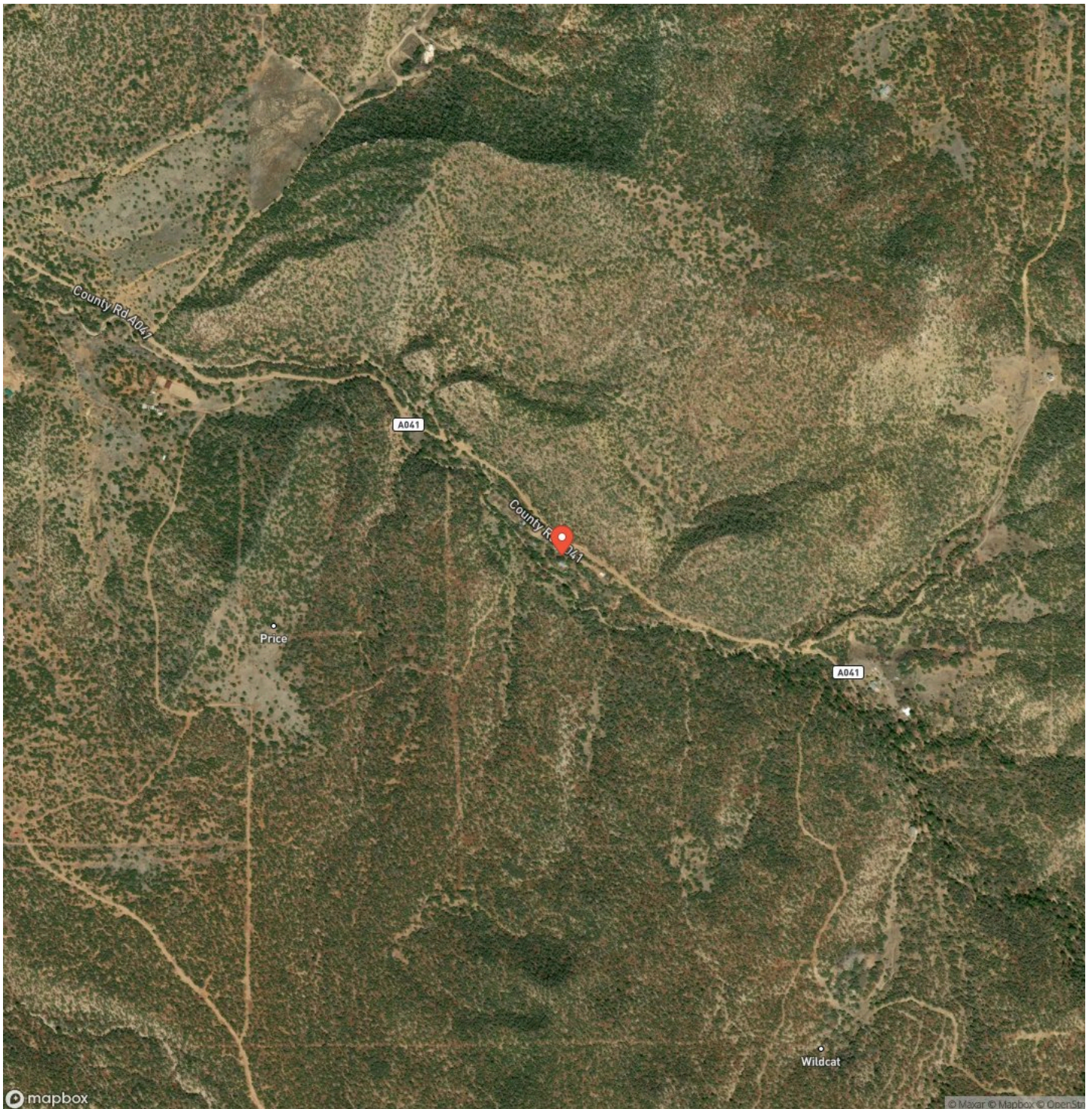
