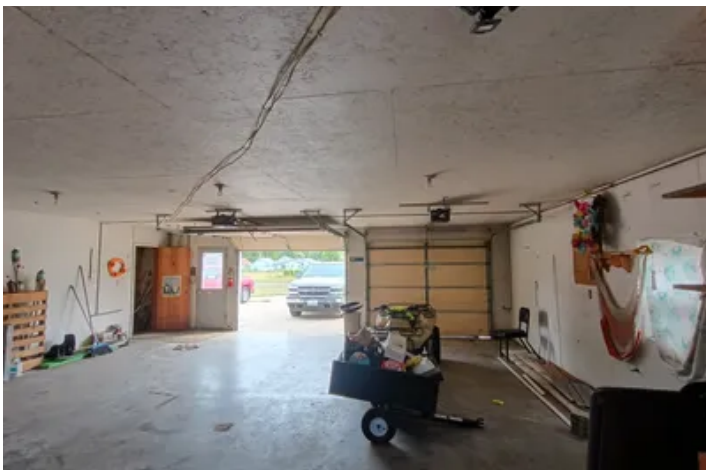

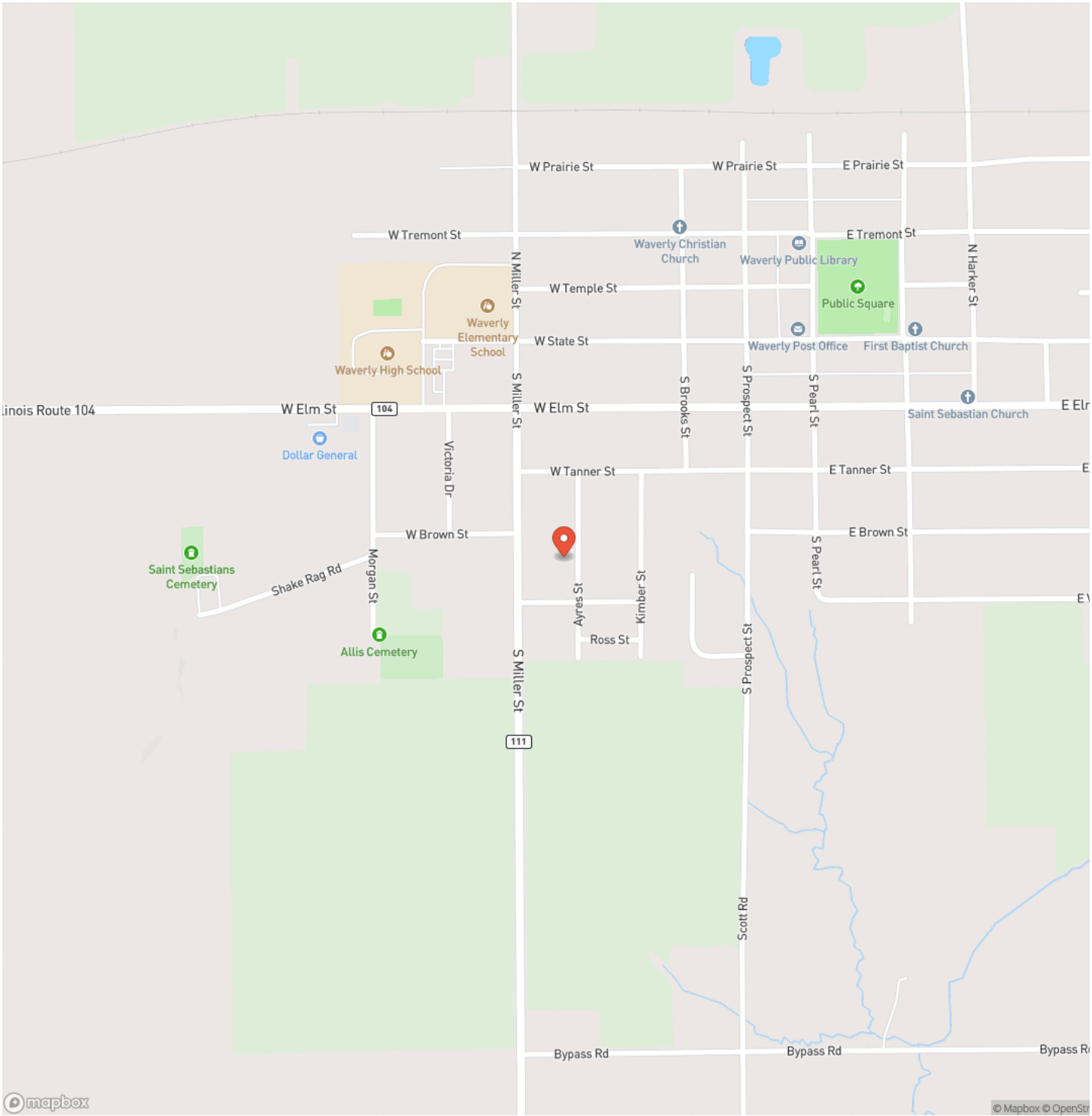

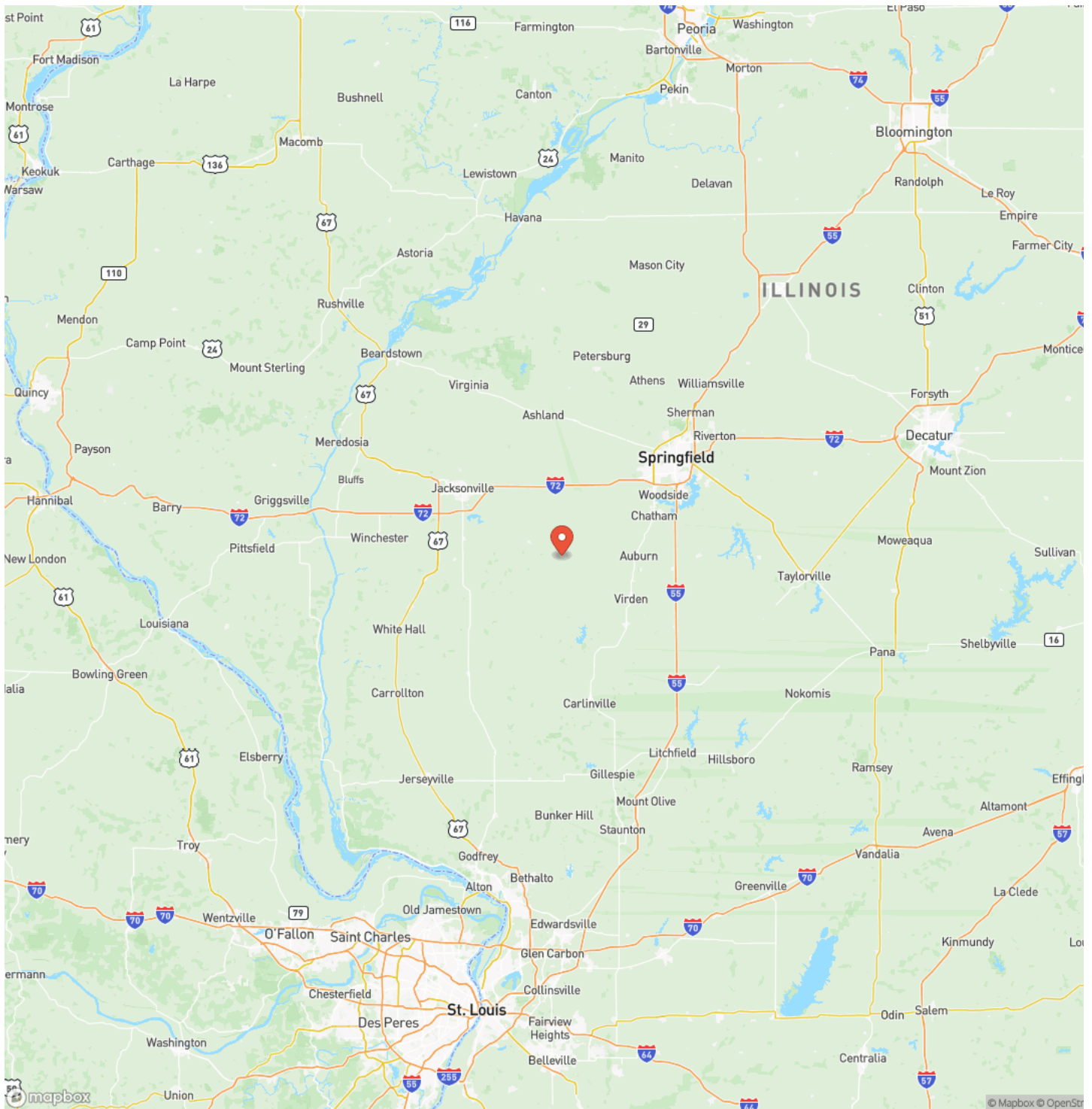


Locator Map

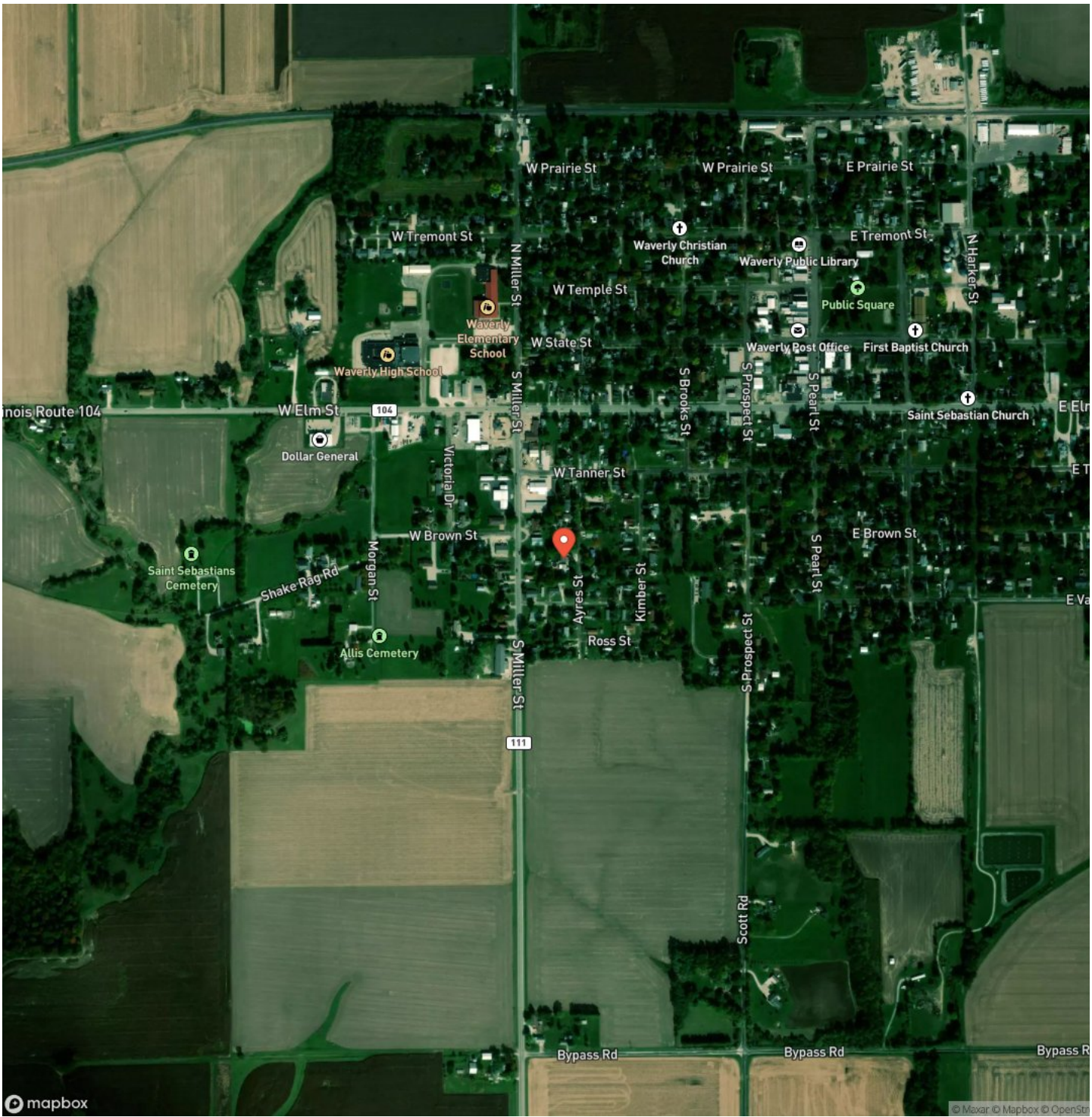
