136+- acres of CRP, CREP, river timber and food plots surrounded by crop fields and rough bluff timbered hills.


Consistent big buck growing, easy to hunt with income!

I've never seen a farm with this many different big bucks on it, ever, anywhere This is an easy place to hunt, either plant the food plots or have someone plant them for you if you dont have time, then crawl up into one of the tower blinds and wait on one of the giants to walk out. This property is 136+- acres (county papers say 136.43) of CRP \$7686 payments through 2031, a small piece of CREP, food plots and over 1.25 mile long strip of mixed hardwoods, which is some Oak, Maple, Pecan and Cottonwood trees and the Sangamon river being the north border and Panther creek on the east border. This entire area is lightly pressured, and no hunting to the east for miles. This property is under a strict management and habitat plan and by looking at the pictures, it obviously works. Grass burning, warm season grasses planted, food plots with row crop, alfalfa, ladino clover, red clover, buckwheat, chicory, Austrian winter pea, and a couple different turnips are some of what was planted for food plots. There are (5) tower blinds that will remain with the property. If you are a waterfowl hunter, there is great duck hunting on the river and there are also 2 duck ponds on the property, both can be planted and flooded. And the goose hunting is potentially amazing on this property, from September with Canadas, and specks through January, and snows and blues January through march. This is a turn key hunting property, come tour the farm and make it yours. Look at all the pictures, high deer density and great bucks! Some pictures are from previous owners and over several years. 
