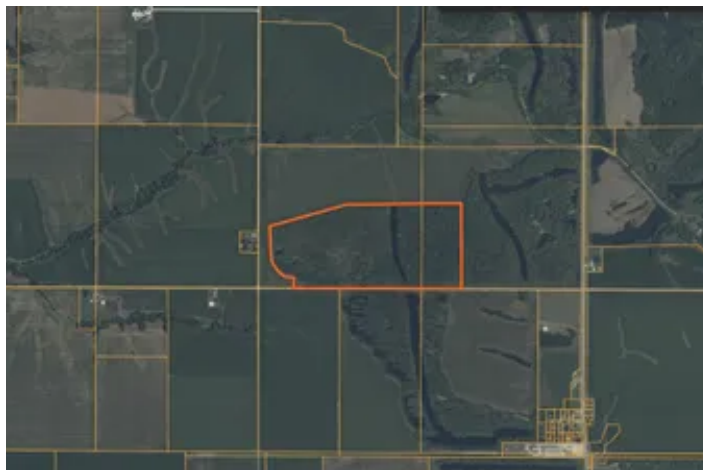
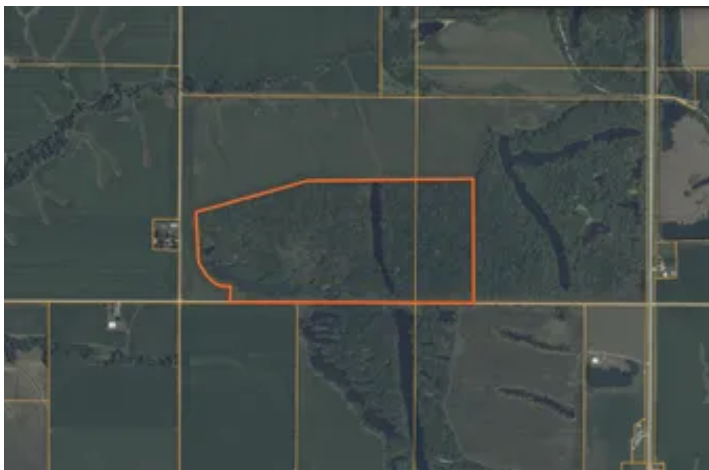

Access is excellent, with two gated entrances and a drivable lane around the timber on the west and north sides.

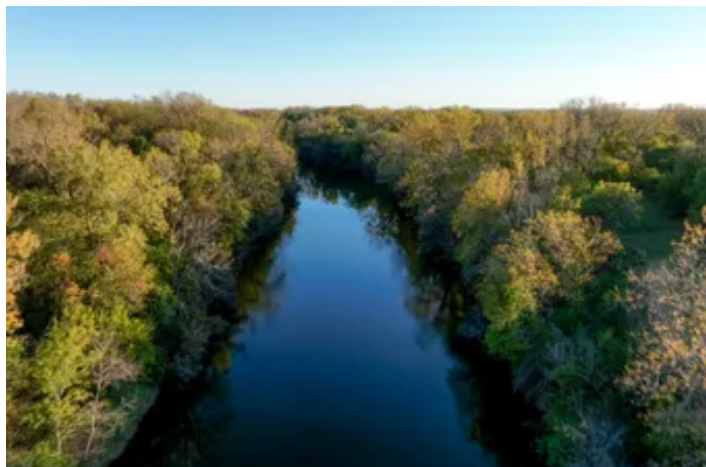

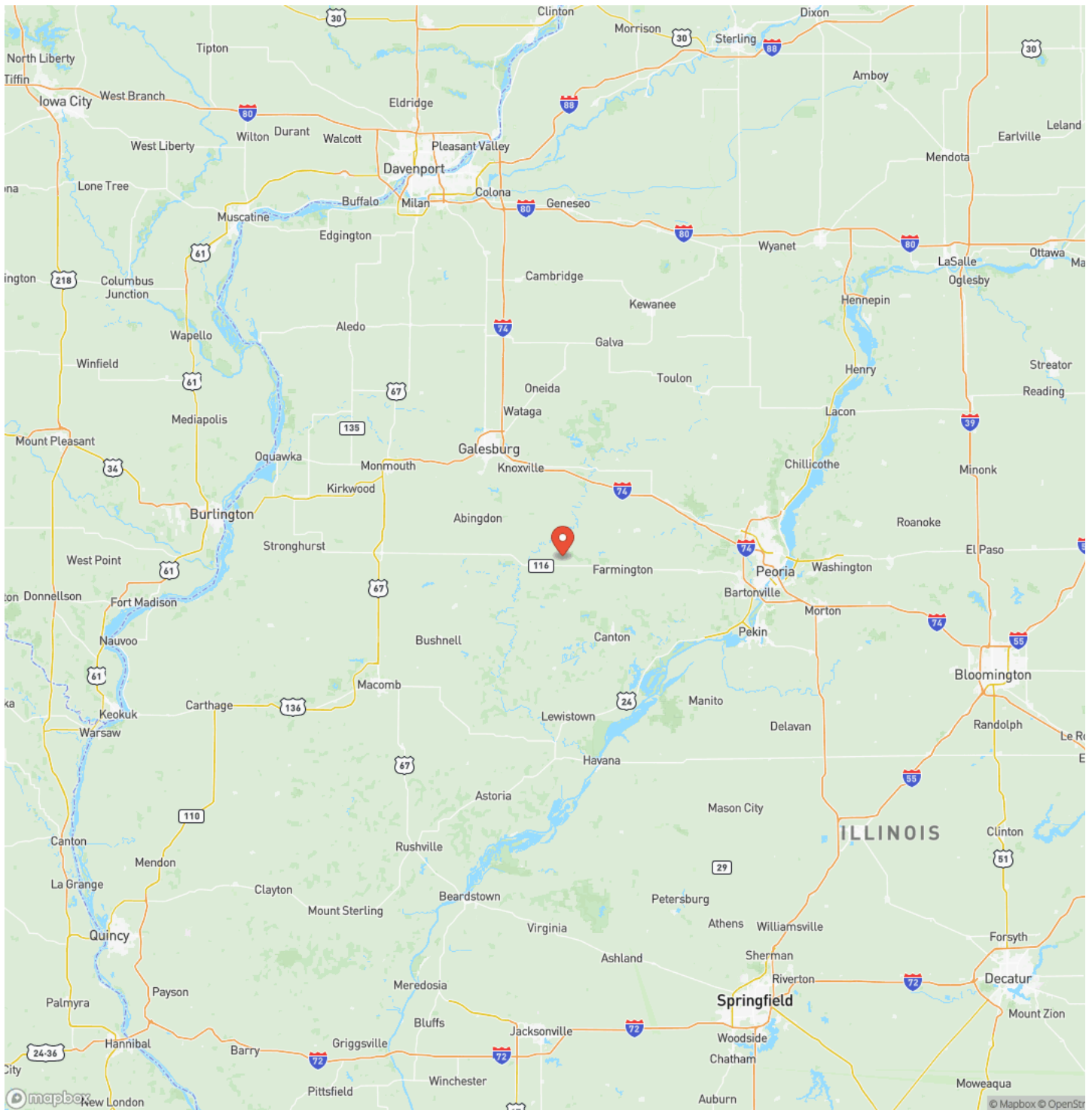
