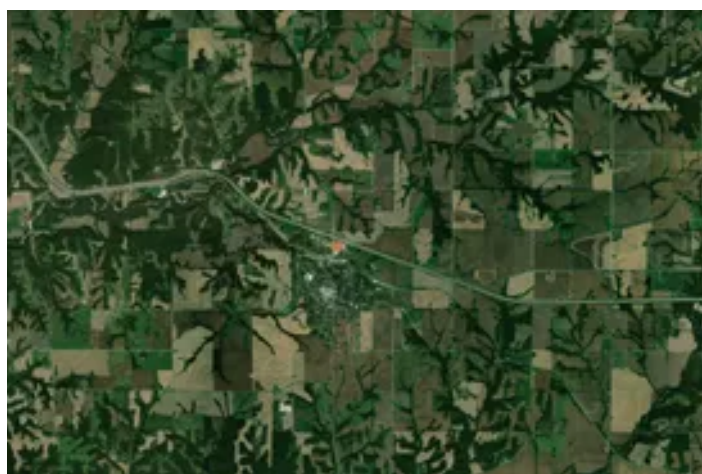

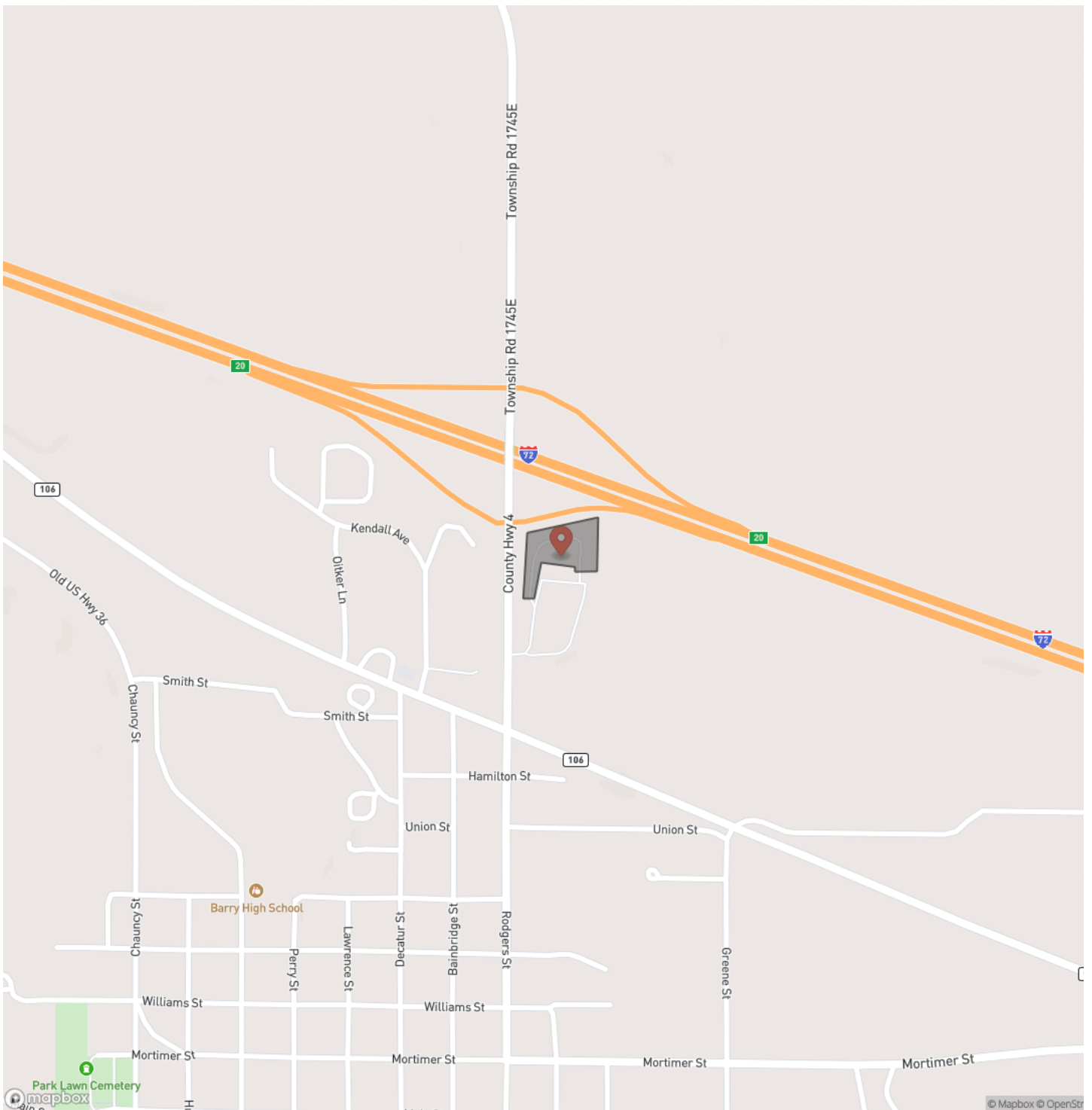

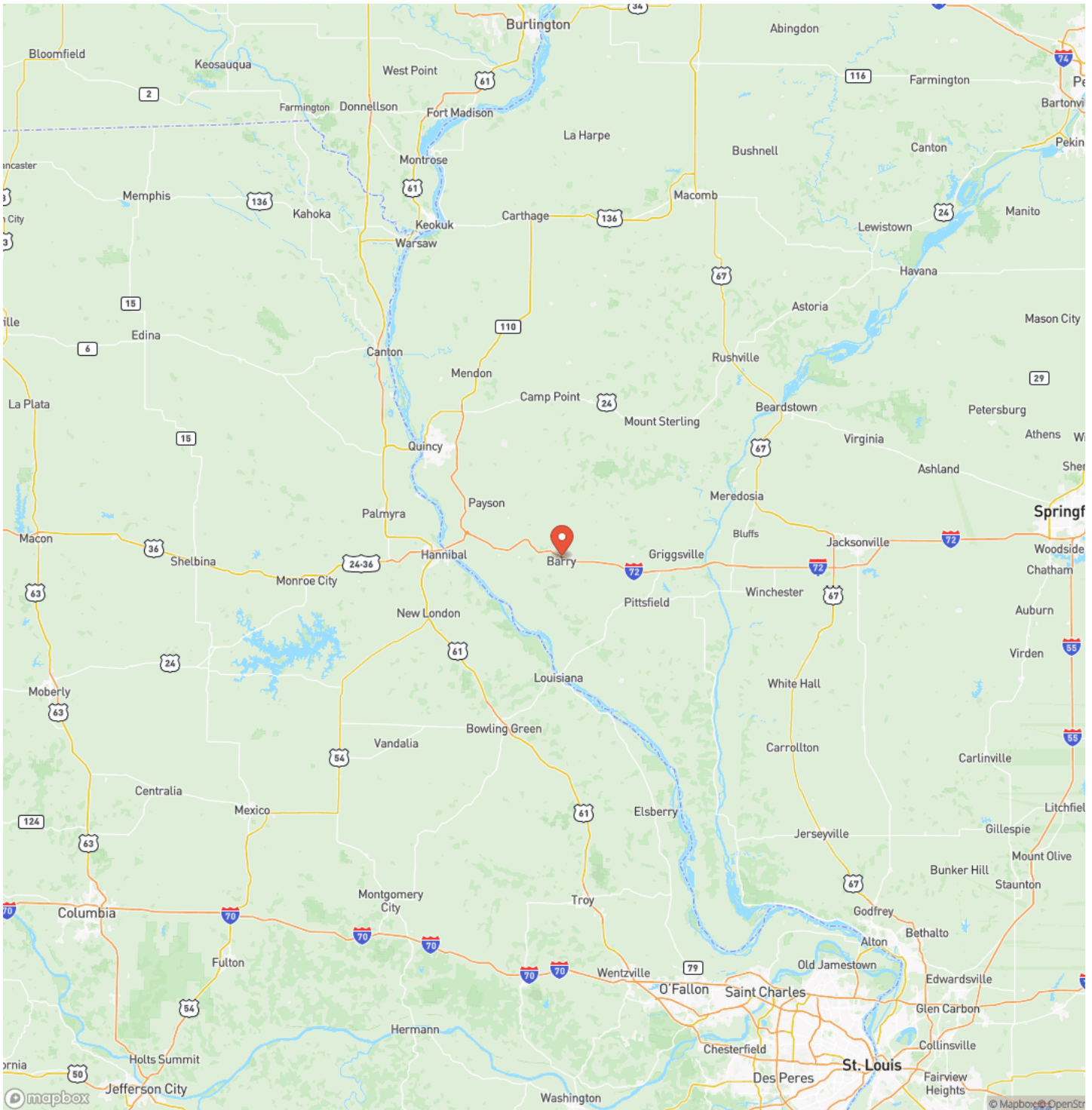


Locator Map
