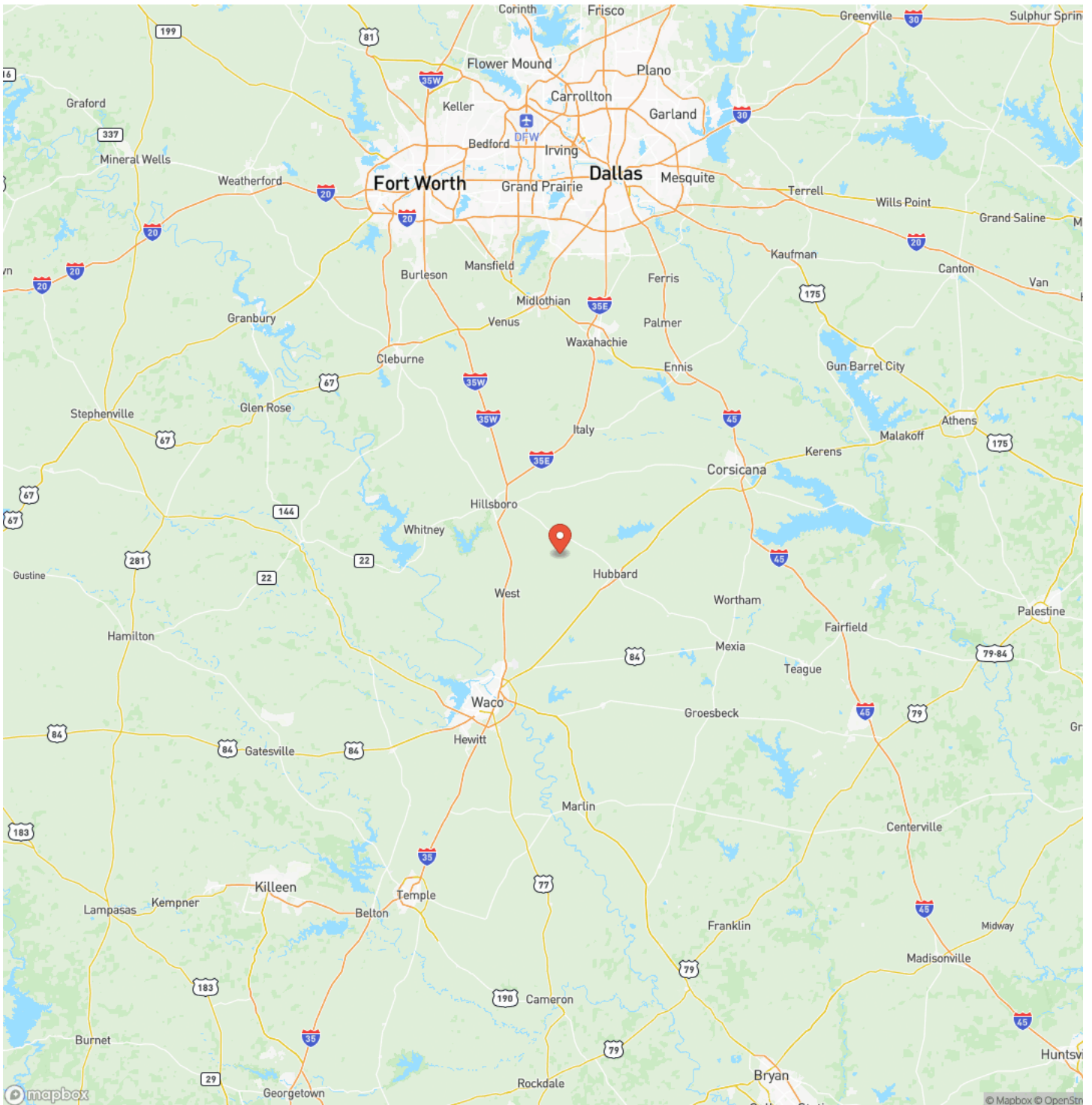


## Locator Map
