THENCE with the southwesterly line of 0.19 acre tract South 37° 20' 11" East a distance of 70.07 feet to a 1 inch iron bolt found for the easterly corner of said 11.086 acre tract:

THENCE South 51° 21' 49" West a distance of 136.73 feet to a 1 inch iron bolt found for corner;

THENCE South 32° 05' 16" East a distance of 71.72 feet to a ½ inch iron rod found for the southeasterly corner of said 11.086 acre tract;

THENCE with the southerly line of said 11.086 acre tract South 82° 18' 00" West a distance of 1041.61 feet (line is basis for bearings - Rec: 1042.70') to a ½ inch iron rod found in the easterly line of said Reserve "A" and being the southwesterly corner of 11.086 acre tract;

THENCE with the easterly line of Reserve "A" and westerly line of 11.086 acre tract North 00° 02' 14" West a distance of 271.11 feet to the POINT OF BEGINNING.
