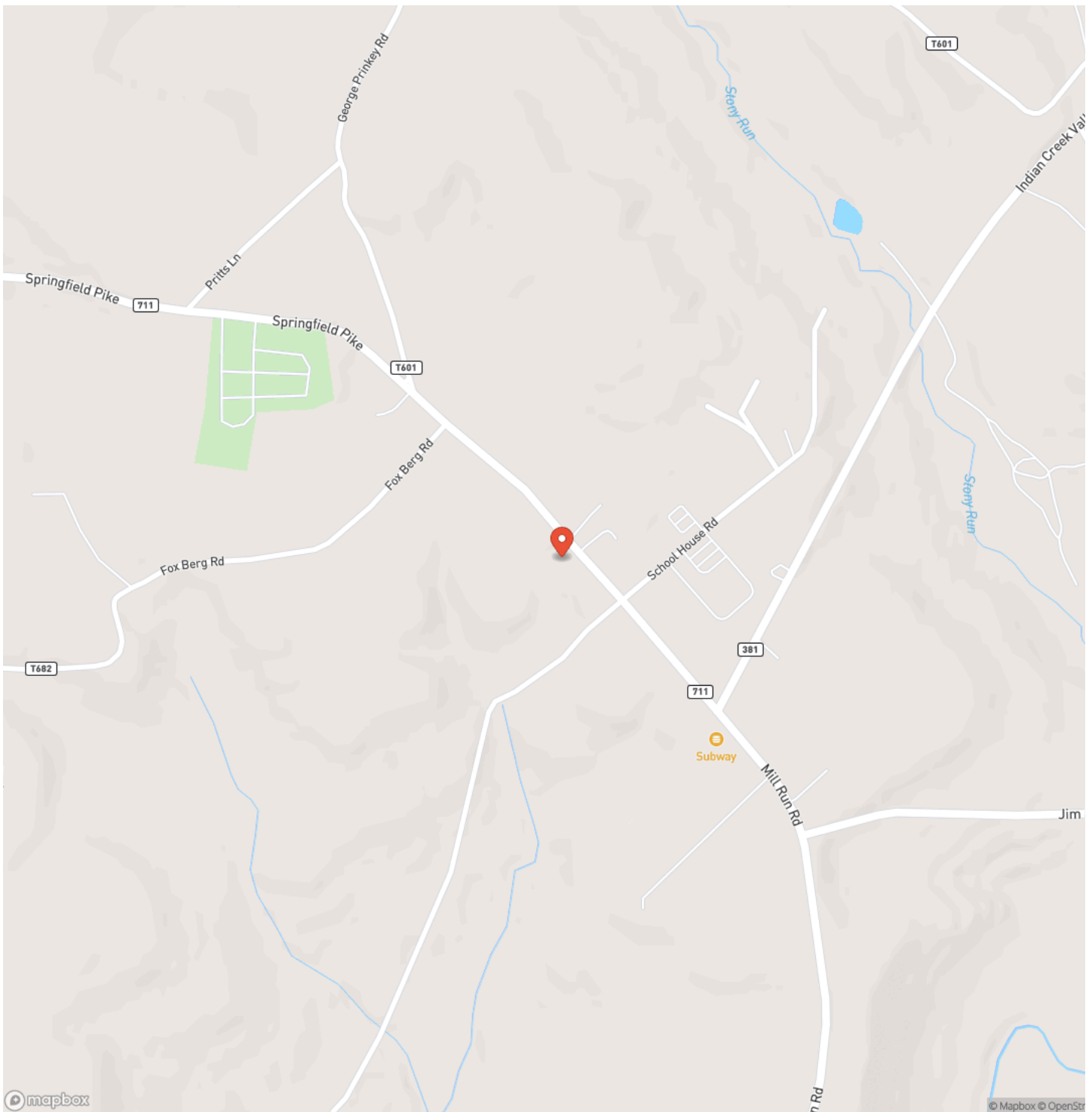

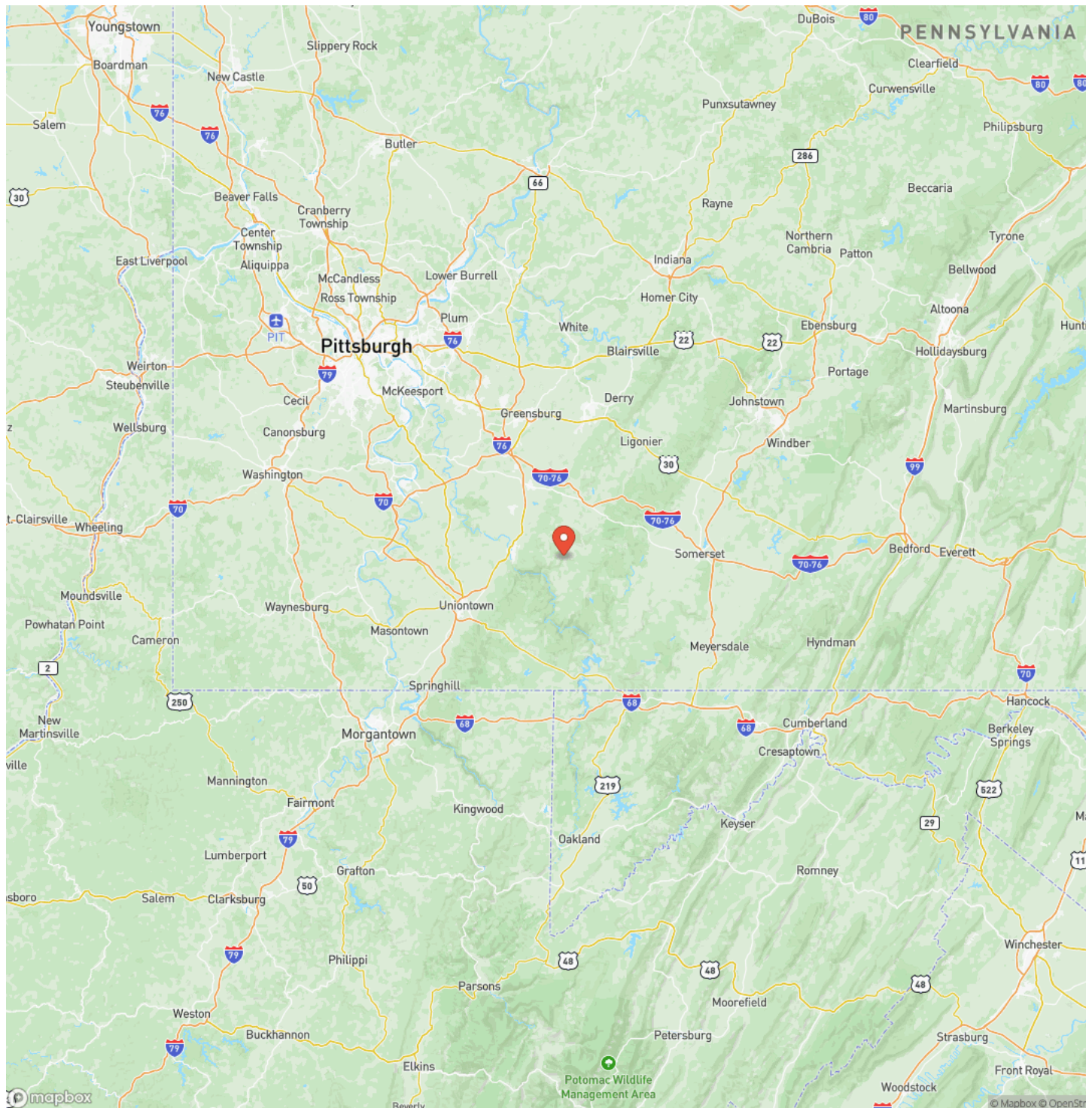


Locator Map

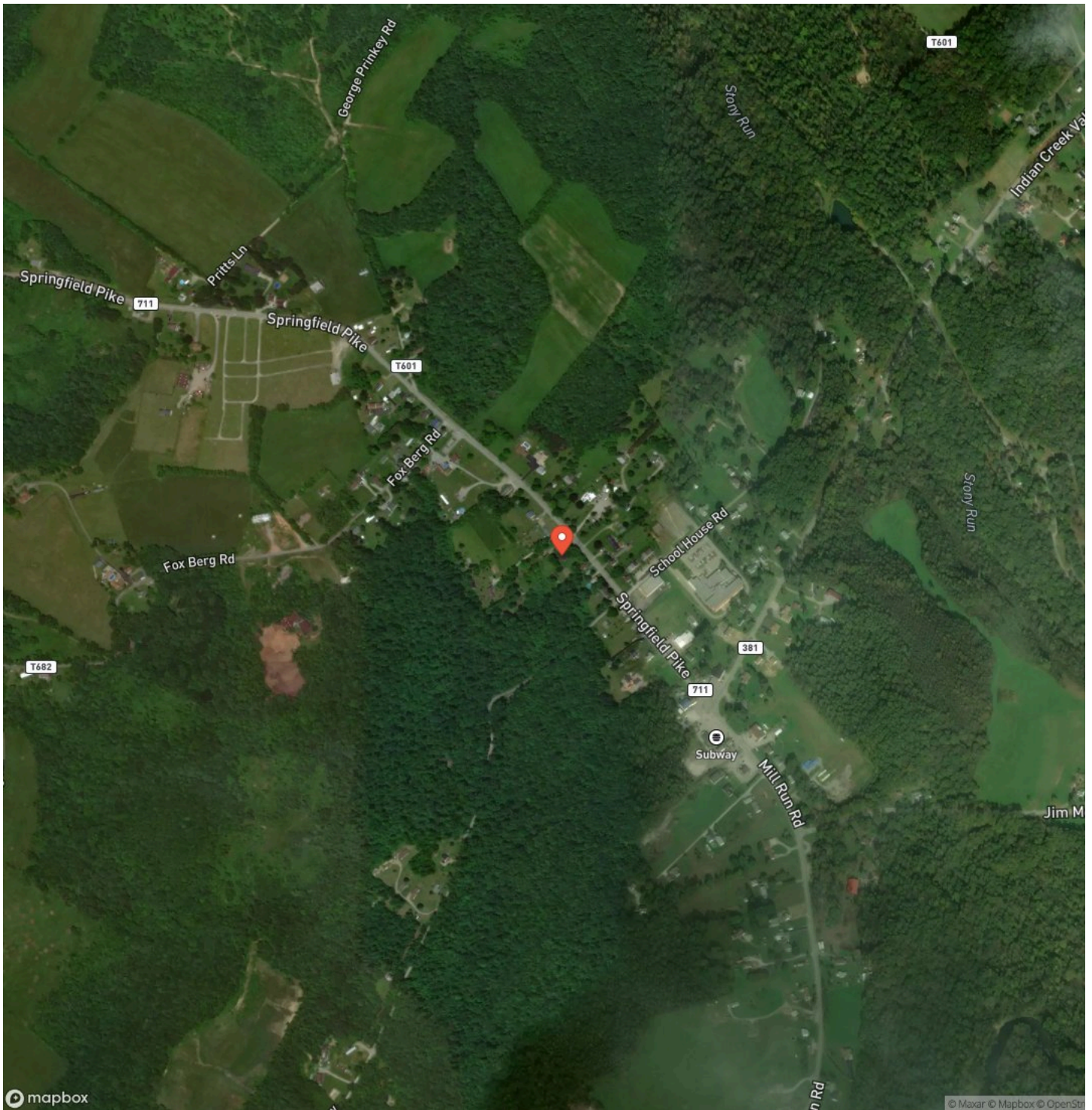
