THENCE S. 69° 31' 16" W., leaving the West line of Mt. Zion Road, along the North occupied line of the Mt. Zion Church tract for a distance of 402.65 feet, (call S. 690 34' W., 402.2 feet) to a 1/2" iron rod found;

THENCE S. 76° 25' 53" W., continuing along said North line, for a distance of 243.70 feet, (call S. 760 37' W., 243.7 feet) to a 60d nail set in a fallen over 30" Red Oak Stump;

THENCE S. 18° 40' 00" E., continuing along said North line for a distance of 64.70 feet, (call S. 180 40' E., 64.70 feet) to a 1/2" iron rod set in the Stump hole of an 18" Pine;

THENCE S. 72° 27' 59" W., continuing along the occupied North line of the Church tract for a distance of 641.19 feet, (call S. 720 23' W., 641.4 feet) to a 1/2" iron pipe found for the Southwest corner of the herein described tract, in the fenced Easterly line of the John R. Kleimann 76.53 acre tract of land as described by deed recorded in Volume 766, Page 891, Montgomery County Deed Records;
